

SERVICE ACTIVATION

POWER ON/OFF

To turn the power on/off, press and hold the $\ensuremath{\textbf{Power}}$ $\ensuremath{\textbf{Key}}.$

CHARGING

1. Insert the small end of the charging cable into the charge port as shown.



2. Connect charger to power outlet

BATTERY

To optimize battery performance, be sure to fully charge your device before using it for the first time.

Optimize Battery Life

To optimize battery life, adjust your screen brightness and display timeout.

1. From the Home screen, press the **Application icon iii** and select **Settings** icon **iii** and then

select the **Display.**


2. Select **Brightness level** to adjust Brightness and Sleep to set **Screen Timeout** to optimize battery life.

SIM CARD

The SIM (Subscriber Identity Module) card identifies your device to the wireless network. A SIM card or Wi-Fi connection is required to browse the Internet.


Insert/Remove the Micro SIM and MicroSD Cards

1. Detach the Micro SIM card from card as shown below. Note: NANO SIM is the smallest SIM size available on the card.



2. Insert Micro SIM/SD card into Micro SIM/SD

slot located on left side of the device. Follow the steps below and the icons on your device to insert Micro SIM/SD card accurately.



3. To remove the SIM or MicroSD card, push the SIM or MicroSD card until it is pop out off its slot.

WI-FI

Connecting to Wi-Fi

- 1. Press the **Application** icon icon from the idle screen to access the **App list** and click on **Settings**
- 2. Tap to turn Wi-Fi on and start scanning for available Wi-Fi networks.
- 3. Tap a network to connect to it. If the network is secured with a lock icon, you will need to enter a security key or password.

4. The Status bar displays icons 🛜 that indicate Wi-Fi status.

Note: If you are out of the Wi-Fi zone or have set Wi-Fi to Off, the device may automatically connect to the Web using mobile data, which may incur data charges.

HOME SCREEN

You can bring all the items (applications, shortcuts, folders and widgets) you love or use most frequently to your Home screen for quick access. Touch the **Home** key to get instant access to the Home screen.



Home screen is provided in an extended format to allow more space for adding applications, shortcuts etc. Slide all Home screens horizontally left and right to get a complete view of the Home screens. The white circles at the lower part of the screen indicate which screen you are viewing.

STATUS BAR

The Status bar appears at the top of your Home screen. You will find icons indicating your tablet's status and new notification alerts appear in the Status bar.

APPLICATIONS

App List

Press the **Application icon** if from the idle screen to access the **App list**.



Add/Remove Application

- 1. Swipe left or right to the desired Home screen.
- 2. Tap the **Application icon** (1) to access the Application menu.
- 3. To add, hold the desired App and drag it to a blank area on the Home Screen. To remove, hold the application you will like to delete until you see the **X Remove icon** on the home page and place it on the icon.

Lock/Unlock the screen

Press the Power key once to light up the screen, slide the screen up, draw the unlock pattern you have created or enter PIN or password to unlock the screen. To set a screen lock you can refer to the parts "Secure Your Device".

PERSONALIZE YOUR DEVICE

Change Wallpaper

You can change your wallpaper in two different ways:

- Touch and hold an empty area on the Home screen and then select WALLPAPERS from bottom options. Slide left and right to view and select one Wallpaper image options, select Set wallpaper on top left bar and then select Home screen to set image as Home screen. You can set different wallpapers for Lock screen and Home screen.
- Change your wallpaper by going to Settings > Display > Wallpaper.

Volume & Ringtone

Adjust Ringtone and Volume

1. From the Home screen, press Application

icon and select **Settings** icon **(**, and then select **Sound**.

- 2. Position the slider to adjust volume for Media,, Alarm, or Notification separately.
- 3. Select **Default notification ringtone** to choose the desired ringtone for Notification and **Default alarm ringtone** for setting alarm ringtone.

SECURE YOUR DEVICE

Help prevent others from using your tablet without your permission by setting a screen lock.

Set a screen lock

- From the Home screen, press the Application icon icon and select Settings icon icon, and then select Security > Screen Lock.
- 2. Select **Pattern, PIN, or Password to** enable screen lock in **Screen Lock** screen.
- 3. Draw an unlock pattern twice or enter a PIN or password twice to create a screen lock.

Deactivate screen lock

Note: Be sure to deactivate this option before you return or exchange your tablet or before factory reset to avoid **PIN**, **Pattern**, or **password** from being required to access tablet.

- 1. From the Home screen, press the **Application** icon icon and select **Settings** icon icon, and then **Security-> Screen Lock**.
- 2. Enter PIN or Password, or draw pattern depending on your previous lock settings to continue.
- 3. Select **None** and then **YES,REMOVE** to disable screen lock in **Screen Lock** screen.

BROWSING



- 1. From the Home screen, press **Application** icon and select **Browser** icon **(**.
- 2 Press the URL bar at the top, and enter the website you want to browser, and press → to search.
- 3. Press icon i on top right to open **Options** menu for further operation.

CONTACTS

Create a New Contact

- 1. From the Home screen, touch **Application** icon (1), and select **Contacts** icon (2).
- 2. Touch 😑 to create a new contact.
- 3. Enter contact's name and other contact information.
- 4. When finished, touch \leq to Save.

G-MAIL

Set Up Gmail Accounts

- 1. From the Home screen, press the Application icon .
- 2. Press G-mail icon.
- 3. Follow the on-screen instructions.

MESSAGING

Use the messaging feature to send and receive text (SMS) and multimedia (MMS) messages.

Create and Send a Message

1. From the Home screen, touch **Application** icon (iii), and select **Messaging** icon (iii) or

press this icon directly from idle screen to enter **Messages**.

- 2. Touch (+) to write text messages.
- 3. Enter the phone number of the recipient in the bar at the top of the page or touch + to add recipients.
- 4. Press the **Type message** bar to enter the text of the message.
- 5. Press the icon > to send text messages.



Send a Multimedia Message

MMS enables you to send sound, emoticons, images, photos, contacts and sounds by pressing the icon rotation to other compatible devices and email addresses.

An SMS will be converted to MMS automatically when media files (image, audio, etc.) are attached.

BLUETOOTH®

Your device comes with Bluetooth connectivity, a wireless technology that enables a data connection between your device and a Bluetooth headset or other Bluetooth device (sold separately).

Connect to Bluetooth

- 1. From the Home screen, press **Application** icon and select **Settings** icon **(2)**.
- 2. Press the **Bluetooth** and touch the switch icon below the Bluetooth to turn the Bluetooth on.
- 4. The device will automatically search for device.
- 5. Select the desired Bluetooth device to pair with your device.

ACCESSING FILES

To access media files and photos saved on your device or to transfer files from your device's SD card to your computer, follow these steps:

Make it Last

Your tablet is a complex electronic device; think of it as a mini-computer. Here are a few tips to help you extend the life of your new tablet.

Do not get your tablet wet. Even a small amount of moisture can damage your tablet and accessories.

Protect your tablet's screen. Your tablet's screen is delicate. To keep it looking and working great, clean the touchscreen and turn off the display when you are not using the device.

Use the original manufacturer's batteries and accessories. Non-approved batteries and accessories can harm and damage your device.

Do not use damaged accessories. If any of your accessories are damaged, replace them and do not attempt to use them. Doing so may damage your device or may result in a fire hazard.

Traffic Safety

Given that studies show that using a mobile device while driving a vehicle constitutes a real risk, even when the hands-free kit is used (car kit, headset...), drivers are requested to refrain from using their mobile device when the vehicle is not parked. Check the laws and regulations on the use of wireless mobile devices and their accessories in the areas where you drive. Always obey them. Do not drop, throw or try to bend your mobile device.

Do not use the mobile device if the screen is damaged, cracked or broken to avoid any injury.

Chargers

Home A.C./ Travel chargers will operate within the temperature range of: 0°C (32°F) to 45°C (113°F).

Radio Waves

THIS MOBILE DEVICE MEETS THE GOVERNMENT'S REQUIREMENTS FOR EXPOSURE TO RADIO WAVES.

Your mobile device is a radio transmitter and receiver. It is designed and manufactured not to exceed the emission limits for exposure to radio-frequency (RF) energy. These limits are part of comprehensive guidelines and establish permitted levels of RF energy for the general population. The guidelines are based on standards that were developed by independent scientific organizations through periodic and thorough evaluation of scientific studies. These guidelines include a substantial safety margin designed to ensure the safety of all persons, regardless of age and health.

The exposure standard for mobile devices employs a unit of measurement known as the Specific Absorption Rate, or SAR. The SAR limit set by public authorities such as the Federal Communications Commission of the US Government (FCC), or by Industry Canada, is 1.6 W/kg averaged over 1 gram of body tissue. Tests for SAR are conducted using standard operating positions with the mobile device transmitting at its highest certified power level in all tested frequency bands.

The FCC has granted an Equipment Authorization for this model device with all reported SAR levels evaluated as in compliance with the FCC RF exposure guidelines. SAR information on this model device is on file with the FCC and can be found under the Display Grant section of HYPERLINK "http://www. fcc.gov/oet/ea/fccid" www.fcc.gov/oet/ea/fccid after searching on FCC ID:2ACCJBT01.

Although the SAR is determined at the highest certified power level, the actual SAR level of the mobile device while operating can be well below the maximum value. This is because the mobile device is designed to operate at multiple power levels so as to use only the power required to reach the network. In general, the closer you are to a wireless base station antenna, the lower the power output of the mobile device. Before a mobile device model is available for sale to the public, compliance with national regulations and standards must be shown. The highest SAR value for this model mobile device when tested is XXX W/Kg for use at the ear and XXX W/Kg for use close to the body.

While there may be differences between the SAR levels of various mobile devices and at various positions, they all meet the government requirement for RF exposure.
