## Section 1: Getting Started

---

This section helps you to quickly start using your device.

### Understanding this User Manual

The sections of this manual generally follow the features of your device. A robust index for features begins on page 176.

Also included is important safety information beginning on page 129, that you should know before using your device.

This manual gives navigation instructions according to the default display settings. If you select other settings, navigation steps may be different.

Unless otherwise specified, all instructions in this manual assume that you are starting from the Home screen. To get to the Home screen, you may need to unlock the device. For more information, see “*Securing Your Device*” on page 13.

---

**Note:** Instructions in this manual are based on default settings, and may vary from your device, depending on the software version on your device, and any changes to the device’s Settings.

Unless stated otherwise, instructions in this User Manual start with the device unlocked, at the Home screen.

All screen images in this manual are simulated. Actual displays may vary, depending on the software version of your device and any changes to the device’s Settings.

---

## Special Text

In this manual, you'll find text that is set apart from the rest. These are intended to point out important information, share quick methods for activating features, to define terms, and more. The definitions for these methods are as follows:

- **Notes:** Presents alternative options for the current feature or menu.
- **Tips:** Provides quick or innovative methods, or useful shortcuts.
- **Important:** Points out important information about the current feature that could affect performance.
- **Warning:** Brings to your attention important information to prevent loss of data or functionality, or even damage to your device.

## Text Conventions

This manual provides condensed information about how to use your device. To make this possible, the following text conventions are used to represent often-used steps:

- Arrows are used to represent the sequence of selecting successive options in longer, or repetitive, procedures. For example:

“From the Home screen, touch  Apps →  Settings.”

## SIM Card

Your device uses a 4G LTE SIM (Subscriber Identity Module). The 4G LTE SIM is a small, rectangular plastic card that stores your device number, information about your wireless service, and other information such as messages and contacts.

If you purchased your device at a Verizon Wireless store, the SIM card is activated and ready to use. If you ordered a new device, the card may need to be activated before you can use it. For more information about activating the SIM card, visit:

---

**Caution!** Do not bend or scratch the SIM card. Take care when handling, installing, or removing the SIM card, and avoid exposing the SIM card to static electricity, water, or dirt. Keep the SIM card out of reach of small children.

---

## Installing the 4G LTE SIM Card

The SIM card must remain in the device when in use.

---

**Important!** Turn the device off before installing or removing the SIM card. To turn the device off, press and hold the Power/Lock Key.



1. Open the SIM card slot and carefully insert the 4G LTE SIM Card into the slot, with the Verizon Wireless logo facing up.
2. Push the SIM card in gently until it clicks into place.

---

**Warning!** Do not insert a microSD or other memory card into the SIM card slot.



## Removing the 4G LTE SIM Card

**Important!:** Turn the device off before installing or removing the SIM card. To turn the device off, press and hold the Power/Lock Key.

1. Open the SIM card slot and gently push the 4G LTE SIM Card inward to release it.
2. Carefully slide the 4G LTE SIM Card out of the slot.




## Memory Card

### Installing a Memory Card

Your device supports removable microSD™ or microSDHC™ memory cards for storage of music, pictures and other files.

1. Locate the microSD card slot on the side of the device and open the cover.
2. Orient the card with the gold strips facing down.
3. Firmly press the card into the slot and make sure that it catches with the push-click insertion.
4. Replace the slot cover.



## Removing a Memory Card

---

**Warning!:** Before removing a memory card, unmount it to prevent loss of data or damage to the card.

For more information, see “*SD card*” on page 119.

---

1. Locate the microSD card slot on the side of the device and open the cover.
2. Firmly press the card into the slot and release it. The card should pop partially out of the slot.
3. Remove the card from the slot.
4. Replace the slot cover.

## Battery

---

Your device is powered by a rechargeable, standard Li-Ion battery. A Wall/USB Charger (Charging Head and USB cable) are included with the device, for charging the battery.

---

**Note:** The battery comes partially charged. You must fully charge the battery before using your device for the first time. A fully discharged battery can requires up to 4 hours of charge time. After the first charge, you can use the device while charging.

---

**Warning!:** Use only approved charging devices. Approved accessories are designed to maximize battery life. Using other accessories may invalidate your warranty and may cause damage.

---

## Battery Indicator

The battery icon  in the System Bar shows battery power level. Before the battery becomes too low to operate, the empty battery icon will flash and a tone will sound. If you continue to operate the device without charging, the device will shut down.

## Charging the Battery

Your device comes with a Wall/USB Charger (Charging Head and USB cable) to charge your device from any 110/220 VAC outlet.

---

**Note:** The battery comes partially charged. You must fully charge the battery before using your device for the first time. A fully discharged battery requires up to 4 hours of charge time.


After the first charge, you can use the device while charging.

When you connect your device to a computer via USB cable, the data connection takes precedence over charging, and the device will only charge when it is turned off.

---

1. Insert the USB cable into the USB port on the device.
2. Connect the USB cable to the charging head.
3. Plug the charging head into a standard AC power outlet.

4. When charging is complete, unplug the charging head from the power outlet and remove the USB cable from the device.



## Turning Your Device On and Off

### Turning Your Device On

- ▶ Press and hold the  **Power/Lock Key**. While powering on, the device connects with the network, then displays the Home screen and active alerts.

### Turning Your Device Off

1. Press and hold the  **Power/Lock Key**.
2. Follow the prompts to confirm the shut-down.

## Setup Wizard

The first time you turn on your device, the Setup Wizard will prompt you to set up the basics on your device.

1. Turn on the device by pressing the  **Power/Lock Key**. You may need to swipe the screen with your finger to unlock it.
2. Follow the prompts to set up your new device:
  - **Language:** Choose a language for your device's screens.
  - **Activation:** If you purchased your device with a monthly plan, it should be active and ready to use. If you need to set up access on a pay-as-you go plan, follow the steps.

- **Google Service Login:** You'll need a Google account to use Google applications. Sign in with your account, or create a new one.
- **Account setup:** Set up accounts on your device, to receive your email and social networking messages on your device.
- **Privacy Caution:** This device can determine its location, which is useful for services such as navigation, shopping, and weather. To protect your privacy, make sure you trust the companies you are downloading from, and read their privacy policies and disclosures carefully. For more information about location settings, see "*Location and security*" on page 107.
- **Location Consent:** Enable location settings to allow applications to use your location. You can always control your location in Location and security settings.

## Your Google Account

Your new device uses your Google account to fully utilize its Android features, including Gmail, Google Talk and Android Market.

When you turn on your device for the first time, follow the prompts to set up a connection with your existing Google account, or create a new Google account.

To create a Google account, or set up your Google account on your device at any time, use Accounts and sync settings. For more information, see “*Accounts and sync*” on page 116.

## Roaming

When you travel outside your home network’s coverage area, your device can roam to acquire service on other compatible digital networks. Roaming during trips outside the USA may result in significantly higher charges. When Roaming is active, the Roaming icon appears in the System bar of the display.

---

**Tip:** You can set your device’s roaming behavior. For more information, see “*Mobile networks*” on page 101.

---

During roaming, some services may not be available. Depending on your coverage area and service plan, extra charges may apply when accessing data networks. Contact Verizon Wireless for more information about your coverage area and service plan.

## Securing Your Device

## Locking the Device

► By default, the device locks automatically when the screen times out.

– or –

Lock the device by pressing the  **Power/Lock Key**.

## Unlocking the Device

Unlock the device using the default unlock, or for increased security, set and use a personal screen lock PIN, password, or pattern.

► Press the  **Power/Lock Key**, then touch and drag the  lock icon across the screen.

1. **3.5mm Headset Jack:** Plug in optional equipment.

## Home Screen



---

---

1. **Action Bar:** Always available at the top of the screen. Updates automatically to provide options, navigation, and other items for the current application or screen. For more information, see *“Action Bar”* on page 20.
2. **Live Panels:** Resizable widgets for real-time access to your content and information. Touch and hold a widget to display resizing controls, or touch and drag to a new location on the Home screen. Touch a widget to display more information, or to customize.
3. **App shortcuts:** Shortcuts to favorite applications from the Home screen. For more information, see *“App Shortcuts”* on page 27. You can also add widgets, folders, or other shortcuts to the Home screen. For more information, see *“Widgets”* on page 25, *“Folders”* on page 29, and *“More”* on page 28.
4. **System Bar:** Always present at the bottom of the screen, to show notifications, system status, and soft keys for navigation. For more information, see *“System Bar”* on page 21.

## Navigation

---

## Touch

Touch items to select or launch them. For example:

- Touch the on screen keyboard to enter characters or text.
- Touch an item to select it.
- Touch an application's icon to launch the application.

## Touch and Hold

Activate onscreen items by a touch and hold gesture. For example:

- Touch and hold a widget or app icon on the Home screen to move it.
- Touch and hold on a field to display a pop-up menu of options.

## Flick or drag

Flick or slide your finger vertically or horizontally across the screen. For example:

- Unlocking the screen
- Scrolling the Home screen or a menu

## Pinch


Using two fingers, make a pinch motion on the screen. For example:

- Pinch in to zoom in on pictures or screens.
- Pinch out to zoom out on pictures or screens.

## Extended Home Screen

The Home screen consists of the Home panel, plus panels that extend beyond the display width to provide more space for adding shortcuts, widgets and folders.

Slide your finger horizontally across the screen to scroll to the left or right side panels. As you scroll, outlines on the right and left of the screen show whether another screen is available.



## Customizing the Home Screen

Customize the Home screen to include your favorite widgets, shortcuts to applications, wallpaper and more.

1. Navigate to the Home screen you want to customize.

2. Touch **+** **Customize** in the Action Bar at the top right of the screen.  
– or –  
Touch and hold on an empty area of the Home screen.
3. Touch a category of items:
  - **Widgets:** Add widgets to the screen. For more information, see “*Widgets*” on page 25.
  - **App shortcuts:** Place a shortcut to an application. For more information, see “*App Shortcuts*” on page 27.
  - **Wallpapers:** Choose an image from Gallery, or select pre-loaded still or live wallpapers. For more information, see “*Wallpapers*” on page 27.
  - **More:** Add shortcuts to specific types of content, such as Browser bookmarks, directions in Maps, a music playlist, or a specific setting. For more information, see “*More*” on page 28.
  - **Folders:** Use folders to store information on the Home screen for easy access. For more information, see “*Folders*” on page 29.
4. Touch an item to place it on the highlighted panel, or touch and hold to drag it to a different panel.

## Action Bar

Action Bar is always available at the top of the screen, and updates automatically to provide access to items related to the current application or screen.

### Google Search

Touch  **Google** to enter criteria to search the web or your device.

Touch  to speak your search criteria.

### Apps

Touch  **Apps** to open the Apps screen to launch applications.

For information about applications, see see *“Applications”* on page 77.

## Customize

Touch  **Customize** to configure the current screen to your preferences.

## Menu

In some cases, a context-sensitive  **Menu** is available at the right side of the Action bar. Touch **Menu** to display options for the current screen or feature.

## System Bar

The System Bar offers navigation tools, plus information about your device's current status.

### Home

Touch  **Home** to display the Home screen.

### Back

Touch  **Back** to return to the previous screen or step.

### Recent apps

Touch  **Recent apps** to display apps you recently launched. From Recent apps, touch an app to return to it. Or, touch and hold Recent apps to launch the Apps screen for access to all apps.

## Quick launch / Screen capture

The Quick launch key is a multifunctional soft key, to allow you to quickly launch a favorite app or feature. By default, it is set to  **Screen Capture**, to take a picture of the current screen and save it to the clipboard.



### Open and Close

Depending on the screen, you can touch  **Open** or  **Close** to move between screens.

## Mini App Tray

The Mini App Tray is available from the System Bar, and offers shortcuts to useful apps, such as Calendar, Task manager and Calculator. The Mini App Tray is available from any screen, so you can launch these apps at any time.



1. From any screen, touch **Open** in the middle of the System Bar to open the Mini App Tray.
2. Slide your finger right and left to scroll the available apps.
3. Touch an icon to launch the application.
4. Touch **Close** in the middle of the System Bar to close the Mini App Tray.

### Customizing the Mini App Tray

You can choose apps to display on the Mini App Tray, and arrange them however you choose.

1. From any screen, touch **Open** in the middle of the System Bar to open the Mini App Tray.
2. Touch **Edit** at the right side of the tray.
3. Touch and drag apps in and out of the tray, or to another position in the tray.
4. Touch **Done** to save your changes.

## Status details

The Status details area of the System Bar shows notifications, the current time, and icons that tell you about messages and device status. Touch Status details to display more information.

Touch items to open them, or touch **X** to dismiss the notification.



## Status & notification icons



**Battery Level:** Shown fully charged.



**Charging Indicator:** Battery is charging.



**Device Power Critical:** Charge immediately. If not charged, device will shut down.



**USB Charging Indicator:** Connected to PC via USB cable. When connected to a PC, the battery only charges when the device is turned off.



**USB Connected:** Connected to a PC using a USB cable.



**Updates Available:** Updates to the applications you have downloaded are available.



**Airplane Mode:** Airplane Mode is enabled. You can use many of your device's features, but cannot access online information.



**New Email Message:** You have new email. Touch the icon to view the notification, then touch a notification to view the email. Icons vary, depending on the provider.



**New Gmail Message:** You have new Gmail. Touch the icon for additional information.



**Configure input methods:** When the keyboard is displayed, touch for a menu of quick keyboard settings.



**Bluetooth Active:** Bluetooth is turned on.



**Music Player:** A song is playing. Touch the Music icon or Status details to see the song title and controls.



**Wi-Fi Active:** Wi-Fi is connected, active, and communicating with a Wireless Access Point (WAP).



**3G Signal:** 3G wireless signal. More bars equal stronger signal, and flashing arrows indicate activity.



**4G LTE Signal:** 4G LTE wireless signal. More bars equal stronger signal, and flashing arrows indicate activity.




**Searching for GPS:** Device is searching for a GPS signal.

## Quick panel

Quick panel displays current date and time, battery status, Wi-Fi status and notification. Touch Status details in the System bar to launch Quick panel.

Slide your finger left and right across Quick settings to find available settings. For more information, see *“Quick Panel”* on page 93.

## Widgets

Place widgets on the Home screen for quick access to your favorites.

### Adding Widgets to the Home screen

1. Navigate to the Home screen where you want to place the widget.
2. Touch and hold on the screen.  
– or –  
Touch  **Customize** in the Action bar.
3. Touch **Widgets** to display available widgets. Scroll the widgets by sweeping your finger right and left.
4. Touch a widget to add it to the selected Home screen  
– or –  
Touch and hold on a widget, then drag it to any Home screen.

### Removing Widgets

- ▶ Touch and hold the widget until  **Remove** appears at the upper right corner of the screen, then drag the Widget to the **Remove** icon.

## Widgets

- **Agenda:** Display upcoming events, and create new events for your Calendar, from the Home screen.

- **Bookmark:** Link directly to a bookmarked web page.
- **Bookmarks:** Display your Browser bookmarks.
- **Books:** Link to your Google Books.
- **Buddies now:** Link to a contact from your accounts.
- **Calendar:** Display a calendar. For more information, see “*Calendar*” on page 82.
- **Contact:** Link to a contact, to view information, send a message, or locate them on a map.
- **Digital clock:** Display the time in digital format.
- **Dual clock:** Display the time in two time zones.

- **Email:** Access Email accounts set up on the device. If you have more than one account set up, all inboxes display. For more information, see “*Email*” on page 45.
- **Gmail:** Access Gmail, Google’s web-based email. For more information, see “*Gmail*” on page 47.
- **Google Search:** Display a Google Search bar, for searching on the Home screen.
- **Latitude:** Locate your friends, and share or hide your location.
- **Market:** Download and manage applications from the Android Market. For more information, see “*Market*” on page 84.
- **Memo:** Create a text Memo on the Home screen.
- **Month:** View the current month’s calendar.
- **Music:** Control music playback from the Home screen. For more information, see “*Music*” on page 55.
- **My Verizon Data:** Launch Browser, to view information about your Verizon account.
- **Pen memo:** Create and save a drawing.
- **Picture frame:** Display a photo from Gallery.
- **Program monitor:** Display the number of active applications, and launch Task manager.
- **Social Hub:** Manage your activities in one location, including incoming messages and social networking updates, email, syncing contacts, and managing schedules and events.
- **The Daily:** Get real-time updates on news, entertainment, culture, opinion, gossip, sports, and tech.
- **Today:** Display today’s events and other tasks.
- **Traffic:** Check the traffic conditions for a set destination.
- **Yahoo! Finance:** View information about your selected stocks.
- **YouTube:** Search YouTube and watch videos.

### Adding Shortcuts from the Home screen

3. Touch **Folders** to display available folders. Scroll the folders by sweeping your finger right and left.
4. Touch a folder to add it to the selected Home screen  
– or –  
Touch and hold on a folder, then drag it to a panel.

### Removing Folders

- ▶ Touch and hold the folder until  **Remove** appears, then drag the folder to the Remove icon.

## Folders

Available folders include:



**New folder:** Create a new, empty folder.



**All contacts:** Create a folder containing all contacts.



**Contacts with phone numbers:** Create a folder containing only contacts with stored phone numbers.



**Received list from Bluetooth:** Create a folder to contain items received via Bluetooth.



**Starred contacts:** Create a folder to contain contacts marked with a star in their contact record (Favorites).

## Entering Text

### Text Input Methods

Your device offers several text input methods:

- **Swype:** Swype is a new text input method that allows you to enter words by gliding your finger over the virtual QWERTY keyboard, lifting your finger between words. You can also enable Word prediction, to match your key touches to words automatically.
- **Android keyboard:** Enter text by touching keys on a virtual QWERTY keyboard. Android keyboard includes predictive text, which matches your key touches to common words so you can select a word to insert it into your text.
- **Samsung keypad:** Enter text by touching keys on a virtual QWERTY keyboard. Samsung keypad includes optional XT9 predictive text, which matches your key touches to common words so you can select a word to insert it into your text.
- **Voice input:** Use the Voice Input option of any keyboard or application to speak your entries.

### Virtual QWERTY Keyboard

Your device offers virtual QWERTY keyboards for text entry. Use the keyboard to enter letters, punctuation, numbers, and other characters into text entry fields or applications.

Touch any text entry field to display a keyboard at the bottom of the screen. By default, when you rotate the device, the screen updates to display the keyboard at the bottom of the screen.

### Choosing the Text Entry Method

You can choose a default entry method in Settings, and choose a method at any time from the System bar.

For information about choosing the default entry method, see “*Current input method*” on page 121.

To change the entry method while entering text, touch  in the System bar, then choose a new keyboard, or voice input.

## Entering Text using Swype

Swype is a new way to enter text on touch screens. Instead of touching each key individually, use your finger to trace over the letters of a word. For each word, place your finger on the first letter and glide to the subsequent letters, lifting on the last letter.

### Swype Help

While entering text, you can get information about Swype.

- Touch and hold  **Swype** to access Settings, for the **How to Swype** tutorial.

### Configuring Swype

Configure Swype options in the Language and input settings. For more information about Swype settings, see “*Configure input methods*” on page 122.

Some useful settings include:

- **Language:** You can use Swype in many languages. In Swype settings, touch **Language**. To switch to another language while entering text, touch  until you find the desired language.

- **Choosing keyboard size:** On the Swype keyboard, touch  to change the keyboard from the full width of the screen to a smaller, movable size (touch and hold on the side of the smaller keyboard to move it from side to side).

### Entering Symbols and Numbers

Using the Swype Keyboard:

- Touch and hold on a key to enter the character at the top of the key.
- Touch and hold on a key until a menu of all characters available on that key appears, then touch a character to enter it.
- Touch  to switch to Symbol mode, then touch a key.

### Using the Numeric Keyboard

Switch to a Numeric Keyboard, to quickly enter numbers and mathematical operators.

- ▶ Touch .

## Editing Keyboard

The Editing Keyboard provides a quick way to move the cursor and highlight text. If the application in which you are working supports editing, you can cut, copy or paste highlighted text.

► Swype from  Swype to .

## Using Swype Voice Input

Enter text by speaking. Swype recognizes your speech and enters text for you.

► Touch  **Voice Input**. At the prompt, speak the text you want to enter.

## Entering Text Using the Samsung Keypad

The Samsung keypad is a custom virtual QWERTY keyboard, featuring optional XT9 predictive text. Input characters by tapping the on-screen keys with your finger, or use speech recognition.

You can enable XT9 predictive text, to have the Samsung keypad match your key touches to common words and displays them. Select a word from the display to insert it into your text.

## Configuring Samsung keypad

Configure the Samsung keypad to your preferences.

- While entering text, touch  → **Configure input methods**, then select  **Settings** next to Samsung keypad.
- For more information, see “*Configure input methods*” on page 122.
- Some useful settings include:
  - To set the size of the Samsung keypad, touch  to toggle between two keyboard sizes.
  - If you have enabled multiple languages, touch  on the keyboard to switch between languages.

## Entering Upper and Lower Case Letters

The default case is Abc, so the first word of sentences is automatically capitalized.

To enter upper and lower case letters:

- Touch  **Shift** to toggle the case.
- Touch and hold to switch to ABC mode.

## Entering Symbols and Numbers

To enter common symbols:

- Touch  to switch to a symbols keypad.
- Touch and hold  for a pop-up menu of symbols and emoticons.

To enter other symbols, touch , then touch  to scroll through three sets of symbols and emoticons.

To enter accented letters or other special letters, touch and hold on the letter to select from a pop-up menu.

To enter numbers:

- Touch  to switch to a symbols keypad.

- In number fields, such as the Phone field in Contact records, the keyboard displays a numeric keypad to make entering numbers easy.

## Using Samsung Keypad Voice Input

Enter text by speaking. Samsung keypad recognizes your speech and enters text for you.

---

**Note:** Enable Voice input in Samsung keypad settings. For more information, see “*Configure input methods*” on page 122.

---

- ▶ Touch  **Voice Input**, then follow the prompts.

## Using Clipboard

- ▶ To attach an item from the Samsung keypad, touch , then touch an item to insert it into the current field or application.

## Using Handwriting

Use the Handwriting feature of the Samsung keypad to enter text by writing with your finger on the screen.

1. Touch  to switch to Handwriting input.
2. Using your finger, write on the screen. You can write in plain text or cursive. When you pause, Samsung keypad interprets your entry and displays the text.
3. Touch  to insert the entry into the text field.
4. Options you can use while handwriting include:
  - Touch  to access numbers and symbols.
  - To access Settings, touch .
  - Touch  to switch between enabled languages.
  - To switch to number writing, touch .
  - Touch  to insert a space.
  - Touch  to switch to the keyboard.
  - Touch  to switch to voice input.

---

## Using XT9 Predictive Text

XT9 is a predictive text entry mode that makes text entry faster by matching your key touches to common words, or words you have saved to your settings.

- To enable XT9 from the Samsung keypad, touch , then touch  next to Samsung keypad, then touch **XT9**.

While entering text:

- As you touch keys, matching words appear at the top of the keypad. Touch a word to insert it.
- For more matching words, touch .
- To add a new word to your settings, touch  → **Add word**.

## Entering Text Using Android Keyboard

The Android Keyboard is a custom virtual QWERTY keyboard, featuring predictive text. Input characters by tapping the onscreen keys with your finger, or use speech recognition.

As you enter characters, predictive text matches your key touches to common words and displays them. Select a word from the display to insert it into your text.

## Configuring Android Keyboard

Configure the Android Keyboard to your preferences.

- While entering text, touch  → **Android keyboard settings**.

---

**Note:** For more information about configuring Android keyboard settings, see “*Configure input methods*” on page 122.

---

## Entering Upper and Lower Case Letters

The default case is lower case (abc). Enter upper and lower case alphabet letters by touching  to toggle the case, before touching the letter key(s).

- Touch once to switch from abc to Abc mode.
- Touch twice quickly to lock the keyboard in ABC mode. Touch the key again to return to Abc mode.

## Entering Symbols and Numbers

To enter common symbols, touch  to switch to symbol mode, then touch the corresponding key.

To enter less-common symbols, touch  → , then touch the corresponding key.

Enter numbers by touching , then touching the number keys.

## Using Android Voice Input

Enter text by speaking. Android Keyboard recognizes your speech and enters text for you.

- ▶ From Android keyboard, touch  **Voice Input**.

## Editing Text

Use the text selection tools to select text or position a cursor for inserting text, then use the editing tools in the Action bar to select, cut, copy and paste text.

---

**Note:** Some applications do not support editing, or may offer other ways to select and modify text.

---

### Inserting new text

- ▶ Touch the text to display the  insertion cursor (touch and drag the cursor into position in the text if needed).

### Selecting text

- ▶ Touch and hold on the text you want to select to display the  selector cursors, then touch and drag the cursors to highlight the text you want to select.

---

**Tip:** Touch **Select all** in the Action bar to select all text in the field. Touch on another area of the screen or touch **Done** to deselect the text.

---

## Copying or cutting text

1. Touch and hold on the text you want to select to display the  selector cursors, then touch and drag the cursors to highlight the text you want to cut or copy.
2. Touch **Cut** or **Copy** from the Action bar at the top right of the screen.

### Pasting copied or cut text

1. Touch in a text entry field to display the  insertion cursor (touch and drag the cursor into position in the text, if needed).
2. Touch **Paste** from the insertion pop-up menu to insert previously cut or copied text.

---

**Note:** If the Paste pop-up menu does not appear automatically, touch the insertion cursor to display it.

---

## Section 3: Accounts and Contacts

---

### Accounts

Your device provides the ability to synchronize information from a variety of accounts, including Google, a Corporate Exchange server, and Email accounts. With synchronization, you can ensure that information on your device is updated with any information that changes in your accounts.

---

---

### Setting Up Your Accounts

Set up and manage your synchronized accounts with the Accounts and sync setting.

For information about setting up email accounts, see “*Configuring Email Accounts*” on page 45.

### Adding an account

1. From the Home screen, touch  **Apps** →  **Settings** → **Accounts and sync** →  **Add account**.
2. Touch an account type, then follow the prompts to enter your credentials and sign in.
3. The device communicates with the provider’s server to set up your account on the device.

### Managing accounts

Configure synchronization of account details, such as calendar events and contacts.

1. From the Home screen, touch  **Apps** →  **Settings** → **Accounts and sync**.
2. Touch an account, to configure settings. Available settings depend on the type of account.

## Contacts

### Creating Contacts

1. From the Home screen, touch  **Apps** →  **Contacts** → .
2. At the prompt, select an account for saving the contact (options depend on the accounts you have set up, and whether a memory card is installed).
3. Touch contact fields to enter information. While entering information, touch  to add fields, or  to delete a field:
  - Touch the blank **Photo** to choose a picture to identify the contact.
  - Enter the contact's name in the **First name** and **Last name** fields, then touch  to enter other name-related fields like **Name prefix**, **Middle name**, and **Name suffix**.
  - Touch **Phone number** to enter a telephone number, then touch  to choose a label from **Home**, **Mobile**, **Work**, **Main**, **Work Fax**, **Home Fax**, **Pager**, **Other**, **Callback** or **Custom** to create a new label.
  - Touch **Internet call** to enter a username for an internet calling service.
4. Touch  **Done** to save the contact.
  - Touch **Email** to enter an email address, then touch  to choose a label from **Home**, **Work**, **Other**, or **Custom** to create a new label.
  - Touch **Instant messenger** to enter a username for an IM service, then touch  to choose a label from **Google Talk**, **AIM**, **Windows Live**, **Yahoo**, **Skype**, **QQ**, **ICQ**, **Jabber**, or **Custom** to create a new label.
  - Touch **Groups** to assign the contact to a group, then touch a group to add the contact to the group. For more information about using Groups, see “*Groups*” on page 43.
  - Touch **Address** to enter a physical address, then touch  to choose a label from **Home**, **Work**, **Other**, or **Custom** to create your own label.
  - Touch **Company name** and **Title** to enter Organization fields.
  - Touch **Add another field** to create new fields for the contact, including **Phonetic name**, **Phone number**, **Email**, **Instant messenger**, **Address**, **Organization**, **Notes**, **Website**, **Event**, **Relationship**, or **Nickname**.

## Updating Contacts

Make changes to update an existing contact.

1. From the Home screen, touch  **Apps** →  **Contacts**.
2. Touch a contact to display it, then touch  **Edit**.
3. Touch contact fields to modify information. While entering information, use these controls:
  - Touch  to add fields.
  - Touch  to delete a field.
  - Touch **Add another field** to create a new field for the contact.
4. Touch  **Done** to save the contact.

## Adding SNS friends

Bring contacts over from your social networks.

1. From the Home screen, touch  **Apps** →  **Contacts**.
2. Touch  **Menu** → **View SNS friends**.
3. Choose account(s), then follow the prompts to import contacts from the account.

## My Profile

My Profile contains your own contact information from the accounts set up on your device. You can send My Profile to friends via Bluetooth, as an attachment in Email, Gmail, or to a Wi-Fi device via Wi-Fi Direct.

1. From the Home screen, touch  **Apps** →  **Contacts**.
2. Touch  **Menu** → **My Profile**.
3. Touch  **Edit**, then touch fields to modify information. While entering information, use these controls:
  - Touch  to add fields.
  - Touch  to delete a field.
  - Touch **Add another field** to create a new field for the contact.
4. Touch  **Done** to save the changes.

## Sending My Profile

1. From the Home screen, touch  **Apps** →  **Contacts**.
2. Touch  **Menu** → **My Profile**.
3. Touch **Send**, then follow the prompts to send the namecard.

## Customizing the Contacts Display

### Choosing contacts to display

1. From the Home screen, touch  **Apps** →  **Contacts**.
2. Touch a tab to choose contacts to display from **Contacts**, **Favorites**, or **Groups**.

### Choosing how contacts display

1. From the Home screen, touch  **Apps** →  **Contacts**.
2. Touch  **Menu** → **Settings** for these options:
  - Touch **Only contact with phones** to only display contacts with a stored phone number.
  - Touch **List by** to sort contacts by first or last name.
  - Touch **Display contacts by** to show contacts by first or last name.
  - Touch  beside an account to choose contacts to display by account-specific attributes (such as group or starred status).

## Joining Contacts

Your device can synchronize contacts with multiple accounts. When you synchronize contacts with your device, you may have multiple contacts for one person. When you join contacts, all the contact's information displays in one Contact record.

Joining also helps you keep contacts updated, because changes in the respective accounts are made automatically when you synchronize with the account.

### Joining contacts

1. From the Home screen, touch  **Apps** →  **Contacts**.
2. Touch a contact to display it.
3. Touch  **Menu** → **Join contact**.
4. Touch a contact to join it to the original contact, then follow the prompts to set the primary contact record.
5. Touch  **Join** to complete the join.

---

**Tip:** If another contact has a similar name, Contacts displays it here for you to choose.

---

## Removing joined contacts

1. From the Home screen, touch  **Apps** →  **Contacts**.
2. Touch a contact to display it.
3. On the contact record, touch the Joined contacts field.
4. Touch  to remove a joined contact.
5. Touch  **Join** to save the change.

## Exporting and Importing Contacts

To back up and restore your contact information, you can export your contact list to a memory card or import your contact list (previously exported) from a memory card.

1. From the Home screen, touch  **Apps** →  **Contacts**.
2. Touch  **Menu** → **Import/Export**.
3. Touch an option, then follow the prompts to complete the operation:
  - **Import from SD card**
  - **Export to SD card**
  - **Import from SIM card**
  - **Export to SIM card**

## Sending Namecards

You can send contact namecards as vCards via Bluetooth to a Bluetooth device, via Wi-Fi Direct, or as an attachment via Gmail or Email.

---

**Note:** Not all Bluetooth devices will accept contacts, and not all devices support transfers of multiple contacts. Check the target device's documentation.

---

1. From the Home screen, touch  **Apps** →  **Contacts**.
2. Touch  **Menu** → **Send namecard via**.
3. Touch contacts to select them, or touch **Select all**, then touch  **Send**.
4. Choose a sending method, then follow the prompts.

## Groups

Assign contacts to Groups to make searching for contacts faster. For more information about displaying contacts by group, see “*Choosing contacts to display*” on page 41.

### Creating a new group

1. From the Home screen, touch  **Apps** →  **Contacts** → **Groups** → .
2. Touch **Tap to enter name**, then enter a name.
3. touch  **Done** to save the new group.

### Working with groups

1. From the Home screen, touch  **Apps** →  **Contacts** → **Groups**.
2. Touch , then select a group to display it.

  - **Send email:** Create an email to members of the group.

---

## Favorites

Identify favorite contacts with .

### Marking Favorites

1. From the Home screen, touch  **Apps** →  
 **Contacts**.
2. Touch a contact to display it, then touch the  **Star** on the contact to mark it. When marked, the star is colored; when unmarked, the star is gray.

**Tip:** To display only starred contacts, touch **Favorites** in the Action bar.

## Social Hub

Social Hub is a smart communication service. Talk to who you want, when you want, and how you want. You can review past conversations and messages (push e-mail, text, and SNS), see what friends are talking about, and let networks know your latest news, all from one place without having to access individual applications. Social Hub supports all major email and social networking portals.

- **Contacts:** Start communications in an integrated contact screen.
- **Inbox:** Manage all your incoming and outgoing messages and conversations from one place.
- **Email:** Set up your email accounts, for real-time access to all your messages.
- **Calendar:** Manage events from all your accounts in one view.

 **Social Hub**.

### Types of Messages

Your device supports these types of messages:

- **Email:** Send and receive email from your email accounts, including Corporate Exchange mail.
- **Gmail:** Send and receive Gmail from your Google account.
- **Google Talk:** Chat with other Google Talk users.

---

**Note:** Messaging service availability depends on your network and service plan. Multimedia Messaging charges apply per your Calling Plan. Monthly plans are available. Higher rates apply for International Multimedia Messaging (when available). Compatible Device required. Consult Verizon Wireless for more information.

---

### Email

Send and receive email using popular email services.

#### Configuring Email Accounts

You can configure Email for most accounts in just a few steps.

#### Configuring the first email account

1. From the Home screen, touch  **Apps** →   
**Email.**
2. Select your email provider, then follow the prompts to set up your email account.

---

## Configuring additional email accounts

1. From the Home screen, touch  **Apps** →  **Email**.

### Syncing Your Email Account

1. From the Home screen, touch  **Apps** →  **Email**.
2. Touch  **Sync** in the Action bar.

## Email Account Settings

Use Account settings to configure handling of your email.

**Note:** Email settings differ, depending on the provider.

---

1. From the Home screen, touch  **Apps** →  **Email**.
2. Touch  in the Action bar, then select an account to view it.
3. Touch  **Menu** → **Settings**.

## Gmail

Send and receive emails via Gmail, Google's web-based email.

### Setting Up Your Gmail Account

The first time you launch Gmail, your device will prompt you to set up your Google account.

1. From the Home screen, touch  **Apps** →  **Gmail**.
2. Follow the prompts to sign in, or create a new account.
3. The device communicates with the Google server to set up your account and synchronize your email.

---

**Note:** You can use more than one Google account on your device. To add another account, touch  **Menu** → **Settings** → **Add account**.

---

## Syncing Your Gmail Account

Sync your account to update messages on your device.

1. From the Home screen, touch  **Apps** →  **Gmail**.

## Managing Your Gmail Account

Use menu options to manage your Gmail.

2. Touch  **Menu** → **Settings**.

## Composing and Sending Gmail

1. From the Home screen, touch  **Apps** →  **Gmail**.
2. Select an account from, then touch  in the Action bar.
3. Touch fields to enter recipients, a subject, and the email text.
4. Touch **Send** to send the message.

## Google Talk

Chat with other Google Talk users.

**Note:** Talk requires that you have a Google account set up on your device. For more information, see “*Setting Up Your Accounts*” on page 37.

► From the Home screen, touch  **Apps** →  **Talk**.

## Section 5: Web

---

### Browser

Your device is equipped with a full HTML Browser, which allows you to access the internet.

### Command Keys

- Touch  **Back** in the window header to return to the previous page, or touch  **Forward** to go forward to a recent page.

### Touching and dragging

- Touch and drag your finger on the screen to navigate pages, and to reposition pages within the screen.

### Entering text in a field

- While browsing, touch a text field to display the virtual QWERTY keyboard to enter text.

### Zoom

- Tap the screen twice to zoom in or out.
- Use two fingers, such as your index finger and thumb, to make a pinch motion on the screen. Pinch to zoom in, and sweep your fingers outward to zoom out.

### Selecting items on a page

While browsing pages, use gestures and menus to navigate:

- Touch an item to select it.
- Touch a hyperlink to follow the link.
- Touch and hold on a hyperlink for options.

### Entering a URL

Access a website quickly by entering the URL.

1. From the Home screen, touch  **Apps** →  **Browser**.
2. Touch the **URL** field at the top of the screen, then enter the URL using the virtual QWERTY keyboard.
3. As you enter characters, potential matches display. Continue entering characters, or touch a match to complete the URL, then touch **Go** to load the page.

## Copying text

Copy information from a web page.

1. From the Home screen, touch  **Apps** →   
**Browser**.
2. Browse to the desired website.
3. Touch and hold on the text to enable the text selector, then use the onscreen tools.

## Using Browser Tabs

You can have multiple tabs open at one time, and you can switch between tabs.

1. From the Home screen, touch  **Apps** →   
**Browser**.
2. To open a new tab, touch  on a new tab.
3. To switch between tabs, touch the tab headers.
4. To close a tab, touch  on the tab header.

## Using Bookmarks

While browsing, bookmark a site to quickly access it later.

### Creating a bookmark

1. From the Home screen, touch  **Browser**.
2. Browse to the desired website, then touch   
**Bookmark**
3. At the prompt, confirm the Label and Address for the bookmark, choose a bookmark folder, then touch **OK**.

### Accessing bookmarks and history

Launch a bookmarked page, or reload recent pages.

1. From the Home screen, touch  **Apps** →   
**Browser**.
2. Touch  **Bookmarks**.
3. On the tabs, use these options:
  - Touch an item to load the page.
  - Touch and hold on an item for options.

**Tip:** Touch and hold  **Back** to display bookmarks and history.

## Google Maps

Use Google Maps to find your current location, get directions, and other location-based information.

---

**Note:** Some features require Standalone or Google location services. For more information, see “*Location and security*” on page 107.

### Navigating the Map

#### Command keys

- To search for a location, touch the field next to , then enter criteria. To speak search criteria, touch .
- To display your location on the map, touch .
- Touch  to launch Places.
- For directions, touch .
- Touch  to choose layers to display on the map.

### Touching and dragging

- Touch and drag your finger on the screen to navigate pages, and to reposition pages within the screen.

### Entering text in a field

- While browsing, touch a text field to display the virtual QWERTY keyboard to enter text.

### Zoom

- Tap the screen twice to zoom in or out.
- Use two fingers, such as your index finger and thumb, to make a pinch motion on the screen. Pinch to zoom in, and sweep your fingers outward to zoom out.

### Latitude

Use Google Latitude to locate your friends on a map, and share or hide your location.

Google Places uses your location to help you find destinations.

► From the Home screen, touch  **Apps** →  **Places.**

## YouTube

View and upload YouTube videos, right from your device.

► From the Home screen, touch  **Apps** →  **YouTube.**

## Google Search

Use Google to search the Web, and for content on your device.

1. From the Home screen, touch  **Apps** →  **Google Search.**
2. Enter search criteria. Search results display automatically. Touch a search result to display it.
3. To choose items for searching, touch  **Menu.**

---

**Tip:** Google Search is also available at the left side of the Action bar on the Home screen.

---

## Section 6: Music

---

### Music Player

Music player plays music and other audio files that you copy from your computer.

You can listen to music from your device's built-in speakers, through a wired headset or via Bluetooth stereo headset or speakers. For more information, see “*Pairing with a Bluetooth Device*” on page 71.

1. From the Home screen, touch  **Apps** →  **Music player**.
2. Music player searches for music on your device and installed memory card, then displays it. Browse music by touching songs, albums, and playlists. Touch a song or playlist to begin playback. Use the tabs on the left side of the screen to change the view of your music library.
3. During playback, use the sound and playback controls:
  - Touch  to mark the song as a favorite.
  - Touch  to view information about the current song.

- Touch and drag in the scale to set volume. You can also press the Volume Key on the side of the device to adjust volume.
- Touch  to enable stereo sound.
- Touch  to launch AllShare, to share music with another device via Wi-Fi.
- Touch and drag in the progress bar to scan forward or backward through the current song.
- Touch  to switch between shuffle and list order.
- Set the repeat options by touching  to repeat the current song,  to repeat all songs until you stop playback, or  to play all songs once then stop.
- Touch  to advance to the next song. Touch and hold  to scan forward through the current song.
- Touch  to go back to the previous song. Touch and hold  to scan backward through the current song.
- Touch  to pause playback. Touch  to resume.

---

**Tip:** If you switch to another application while playing music, touch  in the System bar to display playback controls.

---

## Managing Your Music

### Searching for music

1. From the Home screen, touch  **Apps** →  **Music player**.
2. Touch  **Search**.
3. Type the name of an artist, album, or song.
4. Matching songs are displayed in a list below the search box. Touch a matching song to play it. Touch a matching album, or artist to view a list of songs.

### Creating playlists

1. From the Home screen, touch  **Apps** →  **Music player**.
2. Touch  → **New playlist**.
3. Enter a name for the playlist, then touch **OK**.
4. Add and remove songs:
  - Touch  next to each song, or next to **Add all** to add all songs to the playlist.
  - Touch  to remove a song from the playlist.
5. Touch  **Done** to save the playlist.

## Editing playlists

1. From the Home screen, touch  **Apps** →  **Music player**.
2. Touch **Playlists**, then choose a playlist to display it.
3. Use these options to edit the playlist:
  - Touch  **Menu** → **Rename playlist** to enter a new name.
  - Touch  **Search** to search for new songs to add
  - Touch  **Reorder**, then touch and drag songs to a new playing order.
  - Touch , then add or remove songs using  and .
  - Touch , then touch songs to delete from the playlist and touch  **Remove**. This removes songs from the playlist, but the songs remain in memory.

## Options while playing music

To change settings in the Music player application:

1. From the Home screen, touch  **Apps** →  **Music player**.
2. Touch  **Menu** for options (available options depend on the type of items highlighted):
  - **Delete:** Touch the box for any item, or **Select all**, to mark items for removal. A check mark  indicates selected items. Touch  **Delete** to remove the selected items.
  - **Upload/Download:** Move music between your Backup Assistant Plus account and your device.
  - **Share via:** Share your music using AllShare, Backup Assistant Plus, Wi-Fi Direct, Bluetooth, Gmail, or Email. Select items to share, then touch **Share** and follow the prompts.
  - **Set as alarm tone:** Choose a song and touch **Set** to use the song as an alarm tone. (Only available for individual songs).
  - **Settings:** Configure options:
    - **Advanced** → **Sound settings:** Choose **Equalizer** and **Sound effects** settings.
    - **Advanced** → **Lyrics:** Enable to display song lyrics, if available.

- **Advanced** → **Music auto off:** Select a time period, after which music will stop playing.
- **Music menu:** Select categories for presenting music in the main Music player screen.

## Music

Use Google Music to purchase and download, manage, and play songs synced with your Google account.

---

**Note:** Google Music requires a Google account. Sign in to your Google account to manage music associate with your account.



## Section 7: Pictures and Video

### Camera

Use the built-in Camera to take pictures and record video.

► From the Home screen, touch  **Apps** →  **Camera**.



**Important!** Do not take photos of people without their permission.  
Do not take photos in places where cameras are not allowed.  
Do not take photos in places where you may interfere with another person's privacy.

### Taking Pictures

1. From the Home screen, touch  **Apps** →  **Camera**.
2. Using the display as a viewfinder, compose your picture by aiming the lens at the subject.
  - Touch the screen to focus on the area you touched.
  - To configure settings, see “*Camera Options*” on page 57.
3. To take the picture, touch the **Capture** button.
4. After taking a picture, touch **Image Viewer** to view the picture. While viewing the picture, use these options:
  - “Pinch” the screen, or touch the zoom icons, to zoom in or out, or double-tap to zoom all the way in or out.
  - Touch  **Share via** to share the picture.
  - Touch  **Set as** to assign the picture to a contact, or display as a Lock screen or Wallpaper.
  - Touch  **Delete** to erase the picture.
  - Touch  **Go to Gallery** to launch the Gallery app to view all pictures on your device.

- Touch  **Upload** to upload the picture to your account.
- Touch  **Back** to return to the Camera to take more pictures.

## Camera Options

Use the shortcuts at the left side of the screen to set camera options:

-  **Flash**: Choose Off, On, or Auto flash.
-  **Self-portrait**: Switch to the front camera lens, for self-portraits.
-  **Shooting mode**: Choose an automatic shooting mode, from:
  - **Single shot**: Take a single photo.
  - **Smile shot**: Touch Capture to focus on the subject's face. If a smile is detected, the picture is taken automatically.
  - **Panorama**: Touch Capture to take a picture, then use the on-screen guide to move the camera to take the next 7 shots automatically.
  - **Action shot**: Detects action to automatically take multiple pictures to create a panorama.
-  **Timer**: Set a timer for how long to wait before taking a photo. Options are: Off, 2 sec, 5 sec, and 10 sec.

-  **Exposure value**: Choose a value to set the brightness of the picture.
-  **Settings**
  - **Edit shortcuts**: Configure the shortcuts on the Camera screen. For more information, see “*Editing Camera shortcuts*” on page 58.
  - **Self-portrait**: Switch to the front camera to take a picture of yourself.
  - **Flash**: Set the default flash mode.
  - **Shooting mode**: Set the default automatic shooting mode.
  - **Scene mode**: Choose a mode to match conditions.
  - **Exposure value**: Choose a value to set the brightness of the picture.
  - **Focus mode**: Choose a type of automatic focus.
  - **Timer**: Choose a time period to delay between touching Capture and taking the picture.
  - **Effects**: Apply an effect to pictures.
  - **Resolution**: Choose a resolution for the picture.
  - **White balance**: Choose a setting to match the light source.
  - **Metering**: Select a method for measuring available light.
  - **Outdoor visibility**: Enable or disable automatic adjustments for typical outdoor conditions.

- **Guidelines:** Display lines on the screen to aid in picture composition.
- **GPS tag:** Save GPS location information in the picture details.
- **Storage:** Set the default location for saving pictures.
- **Reset:** Return all camera settings to the defaults.

---

**Tip:** Slide your finger over the list to see all settings.


In Camera Settings, you can choose options to display on the camera screen, for easy access to the option settings.

**Camera.**
2. Touch  **Settings** → **Edit shortcuts.**
3. Touch and drag options to replace a shortcut on the left of the screen:
  - **Guidelines:** Display a grid on the screen to aid in composition.
  - **Scene mode:** Choose a mode to match conditions.
  - **Focus mode:** Choose a type of automatic focus.
  - **Effects:** Apply an effect to pictures.
  - **Resolution:** Choose a resolution for the image.
  - **White balance:** Choose a setting to match the light source.
  - **Metering:** Select a method for measuring available light.
  - **Outdoor visibility:** Enable or disable automatic adjustments for typical outdoor conditions.
  - **GPS tag:** Save GPS location information in the photo details.
  - **Storage:** Set the default location for saving pictures.
  - **Reset:** Change shortcuts to the defaults.

## Camcorder

Use your device's built-in Camcorder to record video.

- From the Home screen, touch  **Apps** →  **Camera**, then slide the mode button to  **Camcorder**.

Do not take videos in places where you may interfere with another person's privacy.

---

## Capturing Video

1. From the Home screen, touch  **Apps** →  **Camera**, then slide the mode button to  **Camcorder**.
2. Using the display as a viewfinder, compose your shot by aiming the lens at the subject. To configure settings, see “*Camcorder Options*” on page 60.
3. To start recording, touch  **Record**. During recording, the Record flashes.
4. To stop recording, touch  again.
5. After recording, touch **Image Viewer** to view the video.

While viewing the video, use these options:

- Touch  **Share via** to share the picture.
- Touch  **Delete** to erase the picture.
- Touch  **Go to Gallery** to launch the Gallery app to view all pictures on your device.
- Touch  **Upload** to upload the picture to your account.
- Touch  **Back** to return to the Camcorder to record videos.

---

**Tip:** Image Viewer options will disappear after a few moments; just touch the screen to display them again.

---

## Camcorder Options

Use the shortcuts at the left side of the screen to set camcorder options:

-  **Flash:** Choose Off or On.
  -  **Self-recording:** Switch to the front camera lens to record yourself.

  -  **Exposure value:** Choose a value to set the brightness of the video.
  -  **Settings:**
    - **Edit shortcuts:** Configure the shortcuts on the Camera screen. For more information, see “*Editing Camcorder shortcuts*” on page 61.
    - **Self-recording:** Switch to the front camera to record yourself.
    - **Flash:** Choose a default flash mode.
- **Recording mode:** Choose normal recording (any length), or limit the recording so that it is suitable for attaching to an email.
  - **Exposure value:** Choose a value to set the brightness of the video.
  - **Timer:** Choose a time period to delay between touching Record and starting recording.
  - **Effects:** Apply an effect to videos.
  - **Resolution:** Choose a resolution for the video.
  - **White balance:** Choose a setting to match the light source.
  - **Outdoor visibility:** Enable or disable automatic adjustments for typical outdoor conditions.
  - **Guidelines:** Display a grid on the screen to aid in composing videos.
  - **Storage:** Set the default location for saving videos.
  - **Reset:** Return all settings to their defaults.

## Editing Camcorder shortcuts

In Camcorder Settings, you can choose options to display on the screen, for easy access to the option settings.

1. From the Home screen, touch  **Apps** →  **Camera**, then slide the mode button to  **Camcorder**.
2. Touch  **Settings** → **Edit shortcuts**.

  - **Storage:** Set the default location for saving videos.
  - **Reset:** Change shortcuts to the defaults.

## Gallery

Use Gallery to view, capture, and manage pictures and videos.

1. From the Home screen, touch  **Apps** →  **Gallery**.
2. Choose items to display by making selections from the menus in the Action bar: **By album**, **By time**, **By location**, **By tags**, or **By size**.
3. Use Action bar buttons:
  - Touch  to switch to Camera.
  - Touch  to view information about pictures and videos.
  - Touch  to view a slideshow of all items, or touch an item to view it.
  - Touch  for options, including:
    - **Images and videos:** Choose whether to view all items, or Images only or Videos only.
    - **Make available offline:** For items you've synced with an online service, select items to be available when your device is not connected to the network or to Wi-Fi.

## Viewing Pictures

1. From the Home screen, touch  **Apps** →  **Gallery**.
  2. Choose items to display by making selections from the menus in the Action bar: **By album**, **By time**, **By location**, **By tags**, or **By size**.
  3. Touch  → **Images and videos** → **Images only** to display only pictures. Touch a picture to view it full-screen.
  4. While viewing a picture, touch the screen for options:
    - Touch  **Slideshow** to view a slideshow of all pictures and videos.
    - Touch  **Share via** to share the picture.
    - Touch  **Upload** to upload the picture to your Backup Assistant Plus account.
    - Touch  **Delete** to erase the picture.
    - Touch  **Menu** for options, including:
      - **Details**: Display information about the photo.
      - **Rotate Left**: Rotate the picture counter-clockwise 90 degrees.
      - **Rotate Right**: Rotate the picture clockwise 90 degrees.
- **Set picture as**: Assign a photo as a Contact photo, Lock Screen, or Wallpaper.
  - **Crop**: Resize the image. Touch and drag the crop box, or move the sides or corners of the crop box to create the crop area, then touch **OK**.
  - **Print**: Send the picture to a Samsung printer via Wi-Fi.
  - **Copy**: Create a duplicate of the picture, saved in the same location.
  - **Motion**: Set the motion option for tilt-zoom. When enabled, you can tilt the device to zoom in or out. For more information, see *“Motion”* on page 117.

## Viewing Videos

1. From the Home screen, touch  **Apps** →  **Gallery**.
  2. Choose items to display by making selections from the menus in the Action bar: **By album**, **By time**, **By location**, **By tags**, or **By size**.
  3. Touch  **Menu** → **Images and videos** → **Videos only** to display videos. Touch a video, then touch  to start playback.
  4. While viewing a video, touch the screen for options:
    - Touch  to advance to the next video. Touch and hold  to scan forward through the current video.
    - Touch  to go back to the previous video. Touch and hold  to scan backward through the current video.
    - Touch  to pause playback. Touch  to resume playback.
    - Touch  to switch between full-screen, letterbox and normal screen playback.
    - Touch and drag the slider to adjust volume. You can also adjust volume by pressing the Volume Key on the side of the device.
    - Touch  to enable or disable stereo sound.
- Touch  to launch AllShare, to share the video with another device via Wi-Fi.
  - Touch  to bookmark a frame in the video, so that you can return to it later using the  **Menu** → **Bookmarks** option.
  - While viewing a video, touch  **Menu** for options, including:
    - **Share via**: Send the video, or post it to an online site.
    - **Trim**: Adjust the length of the video, by dragging the end markers, then touch Trim.
    - **Bookmarks**: View frames you've bookmarked in the video.
    - **Color tone**: Adjust the temperature of the color in the video.
    - **Outdoor visibility**: Enable or disable automatic adjustment of the video playback to enhance viewability outdoors.
    - **Video maker**: Create a movie using this video.
    - **Details**: Display information about the video file.

## Setting a Picture as a Contact Photo

1. From the Home screen, touch  **Apps** →  **Gallery**.
2. Touch a picture to select it.
3. Touch  **Menu** → **Set picture as** → **Contact photo**.
4. Select a contact, or create a new contact, to use the photo.

## Setting a Picture as Wallpaper or Lock Screen

1. From the Home screen, touch  **Apps** →  **Gallery**.
2. Touch a category, then touch a picture to select it.
3. Touch  **Menu** → **Set picture as**, then choose **Lock Screen** or **Wallpaper**.
4. Touch and drag the edges Use the crop tool to edit the picture, then touch **OK** to set the edited picture.

## Sharing pictures and video

Share media via Email, Gmail, Bluetooth, Picasa or YouTube.

1. From the Home screen, touch  **Apps** →  **Gallery**.
2. Touch and hold on an item, then select additional items by touching them.
3. Touch an option:
  -  **Share via**: Send the picture as an attachment, or post it to one of your accounts.
  -  **Upload**: Upload to your Backup Assistant Plus account.
4. Follow the prompts to complete the operation.

2. Touch  **Menu** → **My Account** to log in to your account, or create an account, then follow the prompts to log in.
3. Browse content using these options:
  - **Movies:** Movies you can rent or purchase.
  - **TV Shows:** TV shows you can purchase.
  - **My Media:** Content you have previously purchased or rented.
4. When you find media you want to view, you can watch a preview, then rent or purchase the media.

## Section 8: Connections

---

Your device includes features to connect to the internet and to other devices.

### Wi-Fi

Wi-Fi is a wireless networking technology that provides access to local area networks, and to other Wi-Fi Direct devices.

Wi-Fi networks, or Access Points (WAPs) can be Open (unsecured), or Secured (requiring you to provide login credentials). Your device supports Wi-Fi 802.11 a/b/g/n.

By default, your device will notify you of nearby Wi-Fi networks when you launch a high data usage application. You can also configure your device to automatically connect to known Wi-Fi networks when you launch a high data usage application. To configure these and other Wi-Fi settings, refer to  **Settings > Wireless and networks > Wi-Fi settings**.

### Configuring Wi-Fi Settings

Configure your device's Wi-Fi settings. For more information, see “*Wi-Fi settings*” on page 95.

### Turning Wi-Fi On or Off

Turn your device's Wi-Fi service on or off. When you turn Wi-Fi service on, your device automatically searches for available, in-range Wireless Access Points (WAPs).

1. From the Home screen, touch  **Apps** →  **Settings** → **Wireless and networks**.
2. Touch **Wi-Fi** to turn Wi-Fi On or Off. When on, a check appears in the checkbox.

---

**Tip:** To quickly turn on Wi-Fi from any screen, touch the right side of the **System bar**, then touch **Wi-Fi Off**.

---

## Scanning and Connecting to a Wi-Fi Network

When you turn on Wi-Fi, your device searches for available Wi-Fi connections, then displays them on screen.

1. From the Home screen, touch  **Apps** →  **Settings** → **Wireless and networks** → **Wi-Fi Settings**.
2. Touch **Wi-Fi** to turn Wi-Fi On. When on, a check appears in the checkbox.
3. Your device automatically scans for nearby Wi-Fi networks and displays them. Touch a Wi-Fi network to connect.
4. If the Wi-Fi network is open, you will be automatically connected. If the Wi-Fi network is secured, enter the password at the prompt to connect.

## Adding a Wi-Fi Network Manually

1. From the Home screen, touch  **Apps** →  **Settings** → **Wireless and networks** → **Wi-Fi settings**.
2. Touch **Wi-Fi** to turn Wi-Fi On or Off. When on, a check appears in the checkbox.
3. Your device automatically scans for nearby Wi-Fi networks and displays them. Below the list of networks, touch **Add Wi-Fi network**, then enter these fields:
  - **Network SSID:** Enter the name of the Wi-Fi Wireless Access Point.
  - **Security:** Select the type of security used by the WAP.
    - If Security is Open, continue to set the Proxy settings (optional) and IP settings (optional).
    - If Security is WEP, WPA/WPA2 PSK, or 802.1x EAP, enter the Password and continue to set the Proxy settings (optional) and IP settings (optional).

## Mobile Hotspot

Use the Mobile Hotspot feature to share your device's internet connection with a PC or other device via Wi-Fi.

---

**Note:** Mobile Hotspot consumes battery power and uses data service. While the Mobile Hotspot is active, your device's applications will use the Mobile Hotspot data feature allowance.

---

### Configuring Mobile Hotspot Settings

Configure your device's Mobile Hotspot settings, including your device's name and password, and set the visibility of your device's Wi-Fi hotspot.

## Activating Mobile Hotspot

Activate your device's Mobile Hotspot to allow other devices to use your device's internet connection.

1. From the Home screen, touch  **Apps** →  **Mobile Hotspot**.
2. Touch **Mobile Hotspot** to turn the hotspot On or Off.
3. Your device establishes a connection to the network for the mobile hotspot.
4. Activate Wi-Fi on your PC or other device, then follow the prompts on your devices to connect.

---

**Tip:** By default, your device's mobile hotspot has no security applied, and any device can connect. For more information about configuring your mobile hotspot, see “*Configure Mobile Hotspot*” on page 96.

---

5. When you are finished using Mobile hotspot, touch **Mobile Hotspot** to turn the service off.

## Connecting a Device via Mobile Hotspot

Use the other device's Wi-Fi control to connect to your device's Mobile Hotspot.

1. Activate Mobile Hotspot on your device. For more information, see *“Activating Mobile Hotspot”* on page 69.
2. Activate Wi-Fi on the device, using the device's Wi-Fi control.
3. Scan for Wi-Fi hotspots, and select your device from the list. To find your device's name, see *“Configure Mobile Hotspot”* on page 96.
4. At the prompt, enter your device's Mobile Hotspot password, if you have security enabled. For more information, see *“Configure Mobile Hotspot”* on page 96.

## Bluetooth

Bluetooth is a short-range wireless communications technology for exchanging information over a distance of about 30 feet.

You don't need to line up the devices to send information with Bluetooth. If the devices are in range, you can exchange information between them, even if they are in different rooms.

### Configuring Bluetooth Settings

Configure your device's Bluetooth settings. For more information, see *“Bluetooth”* on page 98.

---

**Note:** Bluetooth profiles are specifications for services supported by individual devices. For a list of profiles your device supports, see *“Bluetooth profiles”* on page 98.

---

### Turning Bluetooth On or Off

1. From the Home screen, touch  **Apps** →  **Settings** → **Wireless and networks**.
2. Touch **Bluetooth** to turn Bluetooth On or Off. When on, a check appears in the checkbox.

## Pairing with a Bluetooth Device

Search for a Bluetooth device and pair with it, to exchange information between your device and the target device. After pairing, your device and the target device will recognize each other and exchange information without a passcode or PIN.

---

**Note:** When paired, the  **Bluetooth** icon displays in the System Bar. If you receive a new request for pairing while paired with a Bluetooth headset, a new Bluetooth icon appears in the System Bar.

---

1. From the Home screen, touch  **Apps** →  **Settings** → **Wireless and networks** → **Bluetooth**.
2. Activate the target device's discoverable mode.
3. Touch **Bluetooth settings** → **Scan for nearby devices**.
4. From the list of scanned devices, touch the target device, then follow the prompts on your device and the target device to complete the pairing. If the target device requires a PIN, enter a PIN for the target device and touch OK. When prompted, enter the PIN on the

target device. If the device allows automatic or smart pairing, your device will attempt to pair with the device automatically.

---

**Tip:** Some devices use a default PIN of 0000. Refer to the target device's user manual.

---

## VPN

You can use your device's VPN (Virtual Private Network) feature to connect to VPNs.

### Configuring VPN Settings

Configure your device's VPN settings. For more information, see “VPN settings” on page 100.

### Adding a VPN

1. From the Home screen, touch  **Apps** →  **Settings** → **Wireless and networks** → **VPN settings**.
2. Touch **Add VPN** to set up a connection to a VPN, using the following settings:
  - **Add PPTP VPN:** Set up a connection to a VPN with Point-to-Point Tunneling Protocol.
  - **Add L2TP VPN:** Set up a connection to a VPN with Layer 2 Tunneling Protocol.
  - **Add L2TP/IPSec PSK VPN:** Set up a connection to a VPN with pre-shared key-based Layer 2/IPsec Tunneling Protocol.
  - **Add L2TP/IPSec CRT VPN:** Set up a connection to a VPN with Certificate-based Layer 2/IPsec Tunneling Protocol.

## Tethering

The tethering features allow you to share your device's mobile data network connection with other devices via USB or Bluetooth.

---

**Note:** Touch **Help** under Tethering settings to view information about tethering, and for links to more information.

---

### USB tethering

Use USB tethering to share your device's network connection with another device that connects to your device via USB cable.

1. From the Home screen, touch  **Apps** →  **Settings** → **Wireless and networks** → **Tethering**.
2. Connect the other device to your device via USB cable.
3. Touch **USB tethering** to turn tethering On or Off. When On, a check appears in the checkbox.

## Bluetooth tethering

Share your device's network connection with another device that connects to your device via Bluetooth.

Before starting, pair your computer with your tablet, then configure your computer to obtain its network connection via Bluetooth.

1. From the Home screen, touch  **Apps** →  **Settings** → **Wireless and networks** → **Tethering**.
2. Touch **Bluetooth tethering** to turn tethering On or Off. A checkmark displays when Bluetooth is On.

---

**Note:** Tethering consumes battery power and increases your data usage. Roaming while using tethering will incur extra data charges.

---

## Mobile networks

Configure your device's use of mobile data network services, including roaming behavior.

---

**Important!:** Depending on your service plan, changes you make to Mobile networks settings may incur extra charges. Consult Verizon Wireless for more information.

---

## Using packet data

Packet data refers to the mobile data network, used to access the internet from your device. You can control whether your device connects to the mobile data network, to control usage (such as while roaming), or to conserve battery power.

1. From the Home screen, touch  **Apps** →  **Settings** → **Wireless and networks** → **Mobile networks**.
2. Touch **Use packet data** to enable or disable your device's connection to the mobile data network.

---

**Tip:** You can control access to packet data from the Quick panel: Touch the Status details in the System bar, then touch Mobile data on the Quick panel.

---

## Configuring Global Data Roaming Access

Accessing the mobile data network while traveling outside the USA may result in significant charges. Use the Global Data Roaming Access to control your device's connection to the network.

---

**Important!:** Depending on your service plan, changes you make to Mobile networks settings may incur extra charges. Consult Verizon Wireless for more information.

---

1. From the Home screen, touch  **Apps** →  **Settings** → **Wireless and networks** → **Mobile networks**.
2. Touch **Global Data Roaming Access** to configure options:
  - Allow access for all trips
  - Allow access only for this trip
  - Deny data roaming access

## System selection

Configure how your device connects to the network when moving in or out of your provider's home network.

1. From the Home screen, touch  **Apps** →  **Settings** → **Wireless and networks** → **Mobile networks**.
2. Touch **System selection** to select the roaming mode for CDMA networks:
  - **LTE automatic:** Allow your device to automatically access the 4G LTE mobile data network when it is available.
  - **CDMA mode:** Choose **Home only** to restrict your device to your provider's network, or choose **Automatic** to allow roaming.

## Connecting to a Computer

### Connecting to a Windows Computer via USB

You can use a USB cable to connect your device to a Windows computer, and transfer music, pictures, and other files between the computer and your device. This connection uses the MTP protocol, supported by most recent versions of Windows.

---

**Note:** If you are using USB tethering, you must turn that off before using USB to transfer files between your device and computer.

---

When you connect your phone to the USB port on your computer, its USB storage is mounted as a drive and appears on your computer screen. You can copy files back and forth as you would using any other external device.

1. Connect your device to the computer with a USB cable.
2. At the prompt, choose a method for transferring files.
3. Transfer files using the selected method.
4. When finished, disconnect the phone from the computer.

---

**Note:** When you connect your device to a computer via USB cable, the data connection takes precedence over charging, and the device will only charge when it is turned off.

---

## Connecting to a Macintosh Computer via USB

You can use a USB cable to connect your device to a computer running Mac OS X with a USB cable, and transfer music, pictures, and other files between the computer and the device.

This connection uses the MTP protocol, which is not supported by Mac OS X natively. Google offers a free Android File Transfer application, available from [www.android.com/filetransfer](http://www.android.com/filetransfer), with installation instructions.

After installing Android File Transfer, follow these steps:

1. If you are using Android File Transfer for the first time, double-click it to open it.

After you start Android File Transfer once, it opens automatically when you connect your device to your computer.

2. Connect your device to the computer with a USB cable. Android File Transfer starts, if it's not already running, and opens a window that displays the contents of your device, along with storage space details at the bottom of the window.

3. Work with this window much as if it were a Finder window: opening and closing folders, creating new folders, and dragging files to or from it and other Finder windows.
4. When finished, disconnect the phone from the computer.

---

**Note:** When you connect your device to a computer via USB cable, the data connection takes precedence over charging, and the device will only charge when it is turned off.

---

## Section 9: Applications

---

### Managing Applications

The Apps screen holds all applications installed on your wireless device. Applications that you download and install from Android Market or from the web are displayed on the My apps tab.

1. From the Home screen, touch  **Apps**.
2. Browse apps by sliding your finger across the screen. There are multiple app screens; just slide your finger left or right until the next screen appears. When you install new apps, additional screens are added to hold them.
3. Touch the tabs at the left of the Apps screen to choose apps to display, from **All** apps installed on your device, **My apps** for apps that you've downloaded and installed, and **Frequent** for apps you open often.

---

**Tip:** You can place shortcuts to applications on the Home screen, for quick access to the application. For more information, see “*App Shortcuts*” on page 27.

---

### Application information

To view information about an App, force an App to stop, uninstall updates, and clear data, use the Information feature.

1. From the Home screen, touch  **Apps**.
2. Touch and hold an App icon, then drag it to  to view App details.
3. Touch  to return to the Apps screen.

## Editing the Apps Screen

1. From the Home screen, touch  **Apps**.
2. Touch  **Edit** to show editing options:
  - Touch  **New folder** to create a folder for grouping shortcuts.
  - To delete an icon, touch and hold until  Remove turns red, then drag the icon to the . Not all icons can be deleted; if the trash can does not turn red when you touch and hold on an icon, it cannot be deleted.
  - To rearrange icons, drag them to a new location in the Apps screen. To move an icon between App screens, drag the icon to the edge of the screen until the next App screen displays, then drop the icon.
3. Touch  **Done** to save changes.

## Downloading and Installing New Apps

Find new apps to download and install on your device, from  **Android Market**,  **V CAST Apps**, or  **Samsung Apps**.

Browse the app stores and follow the prompts to download and install apps on your device.

## Uninstalling Apps

You can uninstall apps you download and install. Pre-loaded apps cannot be uninstalled.

1. From the Home screen, touch  **Apps** →  **Settings** → **Applications** → **Manage applications**.
2. Touch the **Downloaded**, **All** or **Running** tab to find the app, then touch the app to view its details.
3. Touch **Uninstall**, then follow the prompts to uninstall the app.

## Alarm

Set alarms for reminders, or for wake-up times.

---

**Note:** Alarms you set in Alarm are also available in the Analog clock widget.

---

► From the Home screen, touch  **Apps** →  **Alarm**.

## AllShare

Use AllShare to share multimedia content from your device via Wi-Fi with DLNA (Digital Living Network Alliance) certified devices. With AllShare, you can:

Play multimedia content from your device on another player, such as a Wi-Fi-capable TV or other playback device.

Play multimedia content from another source, such as a wireless media server, on your device.

Play multimedia content from another source, such as a wireless media server, on another device. Your device retrieves content from the source and delivers it to another device via Wi-Fi, and acts as a remote to control playback.

---


### Quick Panel

To quickly find and configure often-used settings, use Quick Panel, available from the System bar at the bottom left of the screen.

1. To display Quick Panel, touch the right side of the System bar.



2. Configure on/off settings by touching the icon (slide your finger to scroll right and left to see all on/off settings).



Slide your finger across Quick settings to access all six settings

3. Configure on/off settings by touching the icon (slide your finger to scroll right and left to see all on/off settings):
  - **Mobile data:** Turn access to the Mobile data network On or Off. When ON, you can access the internet with your device.

- **Notifications:** Turn all alerts On or Off. When On, your device will notify you to new messages and other events.
- **GPS:** Turn GPS location information On or Off.
- **Sound/Vibration:** Toggle between your sound settings and Vibrate mode.
- **Auto-rotation:** Turn automatic screen rotations On or Off. When ON, the screen automatically updates when you rotate the device.
- **Bluetooth:** Turn Bluetooth On or Off.

#### 4. Configure other settings:

- **Brightness:** Touch and drag the slider to set screen brightness, or touch AUTO for automatic brightness adjustment.
- **Settings:** Access all Settings.
- **Wi-Fi:** Turn Wi-Fi service On or Off. When Wi-Fi is On, you can connect to Wi-Fi networks.

---

**Tip:** When Quick Settings are displayed, new notifications appear at the bottom of the panel.

---

## Wireless and networks

Control your device's wireless connections.

### Airplane mode

When airplane mode is On, all your device's wireless connections are disabled, and you cannot make or receive calls or messages or connect to networks. While in airplane mode, you can use other features of your device, such as playing music, watching downloaded videos, or other applications.

1. From the Home screen, touch  **Apps** →  **Settings** → **Wireless and networks**.
2. Touch **Airplane mode** to turn it On or Off.

---

**Tip:** You can quickly access Airplane mode from any screen: press and hold the  **Power/Lock Key**, then touch **Airplane mode**.

## Wi-Fi

Set up and manage Wireless Access Points (WAPs). Your device supports Wi-Fi 802.11 a/b/g/n.

### Turning Wi-Fi On or Off

Turn your device's Wi-Fi service on or off. When you turn Wi-Fi service on, your device automatically searches for available, in-range Wireless Access Points (WAPs).

1. From the Home screen, touch  **Apps** →  **Settings** → **Wireless and networks**.
2. Touch **Wi-Fi** to turn Wi-Fi On or Off. When on, a check appears in the checkbox.

---

**Tip:** To quickly access Wi-Fi settings from any screen, touch the right side of the **System bar** to display Quick Settings, then touch **Wi-Fi Off/On**.

---

### Wi-Fi settings

Set up and manage Wireless Access Points (WAPs).

1. From the Home screen, touch  **Apps** →  **Settings** → **Wireless and networks** → **Wi-Fi settings**.

### 2. Touch settings to configure:

- **Wi-Fi:** Touch to turn Wi-Fi On or Off.
- **Notify me:** When enabled, your device automatically notifies you about nearby Wi-Fi networks when you launch high data usage applications.
- **Always connect to known networks:** When enabled, your device will automatically connect to known Wi-Fi networks when you launch a high-data-usage application, even if Wi-Fi is turned off when you launch the application. A known Wi-Fi network is one that you previously connected to using Wi-Fi settings. For more information, see “*Scanning and Connecting to a Wi-Fi Network*” on page 68.
- **Wi-Fi sleep policy:** Specify when to automatically turn off Wi-Fi. This setting can affect the behavior of devices you connect to your device, such as when tethering or using your device as a portable hotspot.
- **Add Wi-Fi network:** Enter the Network SSID and security credentials for a new Wi-Fi network. For more information, see “*Scanning and Connecting to a Wi-Fi Network*” on page 68.

## Mobile Hotspot

Use Mobile Hotspot to share your device's mobile data network connection with a PC or other device via Wi-Fi. For more information about using your device as a mobile hotspot, see “*Mobile Hotspot*” on page 69.

### Turning Mobile Hotspot On or Off

1. From the Home screen, touch  **Apps** →  **Settings** → **Wireless and networks** → **Mobile Hotspot**.
2. Touch **Mobile Hotspot** to turn the hotspot On or Off. When on, a check appears in the checkbox.

---

**Note:** Using your device as a mobile hotspot consumes battery power and increases your data usage. Roaming while using your device as a mobile hotspot will incur extra data charges.

---

## Configure Mobile Hotspot

---

**Note:** Mobile Hotspot must be turned On to configure the hotspot.

---

1. From the Home screen, touch  **Apps** →  **Settings** → **Wireless and networks** → **Mobile Hotspot** → **Network settings**.
2. Touch **Configure** to configure your Mobile Hotspot. Follow the prompts, then select:
  - **Automatic:** Automatically create an SSID and Key for your hotspot.
  - **Manual:** Configure your Mobile Hotspot.
    - **Network Name (SSID):** View and edit your phone's name, used by other devices when connecting to your mobile hotspot.
    - **Broadcast SSID:** Enable to allow your device's Network Name (SSID) to be broadcast, so other devices can search for it. When enabled, a check appears in the checkbox. When disabled, your device is “hidden”, and your hotspot can only be accessed by devices you specifically allow.
    - **Security:** Choose a security level.

- **Password:** Touch to require a password to access your phone as a hotspot, and set a password.
  - **Show password:** Touch to enable display of your password in the Password field. When disabled, the password is not shown.
  - **Broadcast Channel:** Choose Auto to have the phone automatically choose a channel for broadcasting, or choose a channel.
3. Touch **Manage Devices** to view and manage devices you've allowed to connect to your **Mobile Hotspot**, then:
- Touch **View Connected Devices** to see devices connected to your Mobile Hotspot.
  - Touch **Manage Allowed Devices** to manage a list of devices you will allow to connect to your mobile hotspot.
    - Touch **Allow all devices to connect** to allow any device to connect.
    - Touch **Add Device** to enter the MAC address for a new device.

4. Touch **Battery Management** to choose a time period to have **Mobile Hotspot** remain on after you turn it on. If you choose **Always enabled**, the hotspot remains on until you turn it off.

---

**Note:** Using your device as a mobile hotspot consumes battery power and increases your data usage. Roaming while using your device as a mobile hotspot will incur extra data charges.

## Bluetooth

Your device supports Bluetooth® 3.0.

Manage Bluetooth connections, set your device's name, and control your device's visibility to other devices.

---

**Note:** Bluetooth must be turned On to access Bluetooth settings.

---

### Bluetooth profiles

Bluetooth profiles are specifications for services supported by individual devices. Profiles improve the ability of different devices to work together. Your device supports these Bluetooth profiles:

- **Serial Port:** SPP allows a remote Bluetooth device to act as a virtual serial port.
- **Stereo:** A2DP, AVRCP, GAVDP, AVCTP and AVDTP support delivery of stereo audio to compatible Bluetooth devices.
- **Object Exchange:** OPP allows sending and receiving of contact name cards (vCard 2.1), calendar events (vCalendar), and other non-DRM items between devices.
- **Human Interface Devices:** HID supports certain interface devices.

- **Personal Area Network:** PAN profile supports connections between multiple Bluetooth devices.

---

## Tethering

The tethering features allow you to share your device's mobile data network connection with other devices via USB or Bluetooth.

**Note:** Touch **Help** under Tethering settings to view information about tethering, and for links to more information.

## USB tethering

Use USB tethering to share your device's network connection with another device that connects to your device via USB cable.

1. From the Home screen, touch  **Apps** →  **Settings** → **Wireless and networks** → **Tethering**.
2. Connect the other device to your device via USB cable.
3. Touch **USB tethering** to turn tethering On or Off. When On, a check appears in the checkbox.

## Bluetooth tethering

Share your device's network connection with another device that connects to your device via Bluetooth.

1. From the Home screen, touch  **Apps** →  **Settings** → **Wireless and networks** → **Tethering**.
2. Touch **Bluetooth tethering** to turn tethering On or Off. A checkmark displays when Bluetooth is On.

---

**Note:** Bluetooth tethering consumes battery power and increases your data usage. Roaming while using Bluetooth tethering will incur extra data charges.

---

## VPN settings

Set up and manage Virtual Private Networks (VPNs). For more information about using VPNs, see “VPN” on page 72.

### Adding a VPN

1. From the Home screen, touch  **Apps** →  **Settings** → **Wireless and networks** → **VPN settings**.
2. Touch **Add VPN** to set up a connection to a VPN, using the following settings:

Set options for roaming, networks and APNs.

#### Vibration intensity

Set the intensity of vibration feedback for Notifications and Haptic feedback for screen touches

To enable Haptic feedback, see “*Haptic feedback*” on page 103.

1. From the Home screen, touch  **Apps** →  **Settings** → **Sound** → **Vibration intensity**.
2. Touch and drag the slider to set the strength of the vibration for Notifications and Haptic feedback.
3. Touch **OK** to save your setting.

## Notifications

### Notification ringtone

Select a default ringtone for message, alarm, and other notifications.

1. From the Home screen, touch  **Apps** →  **Settings** → **Sound** → **Notification ringtone**.

## Feedback

### Audible selection

When enabled, tones play when you touch the screen for selections.

2. Touch **Audible selection** to enable or disable tones.  
When enabled, a check mark appears in the check box.

## Screen lock sounds

When enabled, tones play when unlocking and locking the screen.

1. From the Home screen, touch  **Apps** →  **Settings** → **Sound**.
2. Touch **Screen lock sounds** to enable or disable tones.  
When enabled, a check mark appears in the check box.

## Haptic feedback

When enabled, the device vibrates to indicate screen touches and other interactions.

1. From the Home screen, touch  **Apps** →  **Settings** → **Sound**.
2. Touch **Haptic feedback** to enable or disable vibration.  
When enabled, a check mark appears in the check box.

---

**Note:** To set the intensity of Haptic feedback, use the Vibration intensity setting. For more information, see “*Vibration intensity*” on page 102.

---

## Screen

### Brightness

Set the default screen brightness.

Set the level of animations for transitions between screens.

Set the function for the multifunctional soft key, available on the System bar next to the Back, Home, and Recent apps soft keys.

2. Choose an option to select it.

## Auto adjust screen power

Save power by allowing the device to analyze the display to automatically adjust the LCD brightness.

## Horizontal calibration

Adjust the calibration of the display.

- **Brightness:** When On, screen brightness will automatically set to the Brightness level you choose when Power saving mode starts.
- **Brightness:** Choose a brightness level for the device to use in Power saving mode.
- **Timeout:** Choose delay between the last screen touch and screen timeout after Power saving mode starts.

## Standalone GPS services

Enable or disable location service from GPS satellites.

1. From the Home screen, touch  **Apps** →  **Settings** → **Location and security**.
2. Touch **Standalone GPS services** to enable or disable GPS satellite services. When enabled, a check mark appears in the check box.

## Use location data for Google Search

Enable or disable use of location information for Google Search, Voice Search and other Google services.

---

**Important!:** By selecting **Use location data for Google Search**, you are allowing access to all location information by Google through web access or any software or peripheral components you choose to install, download, add or attach to the device or any other means. Enabling this functionality could pose certain risks to users of this device.

---

1. From the Home screen, touch  **Apps** →  **Settings** → **Location and security**.
2. Touch **Use location data for Google Search** to enable or disable Google location services. When enabled, a check mark appears in the check box.

## Lock Screen

### Configure lock screen

Choose settings for unlocking your screen. For more information about using the lock and unlock features, see “*Securing Your Device*” on page 13.

1. From the Home screen, touch  **Apps** →  **Settings** → **Location and security**.
2. Touch **Configure lock screen** for these settings:
  - **Off:** Disable all lock settings, so the screen will never lock.
  - **Unsecure:** The default lock level. If you have previously set a security lock, touch to remove the security Pattern, PIN or Password.
  - **Pattern:** A screen unlock pattern is a touch gesture you create and use to unlock your device. Follow the prompts to create or change a screen unlock pattern.
  - **PIN:** Select a PIN to use for unlocking the screen.
  - **Password:** Create a password for unlocking the screen.
3. Touch **Owner information** to enable display of your own text on the lock screen. Touch the text field to enter text for the display.

## Encryption

### Encrypt device

As a security measure, you can encrypt the contents of your device and require a PIN or password to decrypt the contents each time you turn it on.

1. From the Home screen, touch  **Apps** →  **Settings** → **Location and security**.
2. Touch **Encrypt device** to start encryption. Follow the prompts to complete encryption.

### Encrypt SD card

As a security measure, you can encrypt the contents of an installed SD card, and require a PIN or password to decrypt the contents each time you access the card.

1. From the Home screen, touch  **Apps** →  **Settings** → **Location and security**.
2. Touch **Encrypt SD card** to start encryption. Follow the prompts to complete encryption.

## ***SIM card lock***

### **Set up SIM card lock**

As a security measure, you can choose to require a PIN for accessing the SIM card to use your device.

1. From the Home screen, touch  **Apps** →  **Settings** → **Location and security**.
2. Touch **Set up SIM card lock** for these settings:
  - **Lock SIM card:** Enable to require a PIN be entered for access to the SIM card, then set the PIN.
  - **Change SIM PIN:** Enter a new PIN for accessing the SIM card.

## ***Passwords***

### **Visible passwords**

When enabled, password characters will display briefly as you enter them.

1. From the Home screen, touch  **Apps** →  **Settings** → **Location and security**.
2. Touch **Visible passwords** to enable or disable brief displays of password characters. When enabled, a check mark appears in the check box.

## ***Device administration***

### **Device administrators**

Add or remove device administrators, used by some applications when synchronizing with your device.

1. From the Home screen, touch  **Apps** →  **Settings** → **Location and security**.
2. Touch **Device administrators**.

## Credential storage

### Use secure credentials

You can install credentials from USB storage (stored on a memory card), and allow applications to access the secure certificates and other credentials. Secure credentials are used to establish some kinds of VPN and Wi-Fi connections.

---

**Note:** You must have installed encrypted certificates to use this feature.

---

1. From the Home screen, touch  **Apps** →  **Settings** → **Location and security**.
2. Touch **Use secure credentials** to enable or disable. When enabled, a check mark appears in the check box.

### Install from USB storage

Install encrypted certificates from USB storage.

1. From the Home screen, touch  **Apps** →  **Settings** → **Location and security**.
2. Touch **Install from USB storage**, then choose a certificate and follow the prompts to install.

## Set password

Set or change a password to protect credentials.

1. From the Home screen, touch  **Apps** →  **Settings** → **Location and security**.
2. Touch **Set password**, then follow the prompts.

## Clear storage

Clear stored credentials and reset the password.

---

**Note:** This setting only appears if you have installed encrypted certificates.

---

1. From the Home screen, touch  **Apps** →  **Settings** → **Location and security**.
2. Touch **Clear storage** to clear stored credentials and reset the password.

## Applications

You can download and install applications from Android Market, V CAST Apps, or Samsung Apps, or create applications using the Android SDK and install them on your device. Use Applications settings to manage applications on your device.

---

**Warning!:** Because this device can be configured with system software not provided by or supported by Google or any other company, end-users operate these devices at their own risk.

---

### Manage applications

Manage and remove applications from your device.

1. From the Home screen, touch  **Apps** →  **Settings** → **Applications** → **Manage applications**.
2. Touch the **Downloaded**, **All** or **Running** tab to view and update information about applications, including memory usage, default settings and permissions.

3. While viewing application details, use the controls to **Force stop** the application (closes the application), **Uninstall updates** or **Uninstall** (uninstall is only available for applications you install), **Clear data**, **Clear cache**, or **Clear defaults**.

### Running services

View and control services running on your device.

---

**Warning!:** Not all services can be stopped, and stopping services may have undesirable consequences on the application or Android System.

---

1. From the Home screen, touch  **Apps** →  **Settings** → **Applications** → **Running services**.
2. To stop a service, touch the service, then touch **Stop** at the confirmation prompt.

## Memory usage

View memory usage for applications running on your device.

2. Touch an application to view and update information about Downloaded, All or Running applications.

## Battery use

View power usage for applications running on your device.

1. From the Home screen, touch  **Apps** →  **Settings** → **Applications** → **Battery use**.
2. Touch a process to view and update information about running processes.

## Unknown sources

When enabled, allows installation of applications from sources other than the Android Market.

1. From the Home screen, touch  **Apps** →  **Settings** → **Applications** → **Unknown sources**.
2. Touch **Unknown sources** to enable or disable the setting. When enabled, a check mark appears in the check box.

## Development

Set options for application development.

### USB debugging

When enabled, allows debugging when the device is attached to a PC by a USB cable.

1. From the Home screen, touch  **Apps** →  **Settings** → **Applications** → **Development**.
2. Touch **USB debugging** to enable or disable the setting.  
When enabled, a check mark appears in the check box.

### Stay awake

When enabled, the screen will never go to sleep while charging.

1. From the Home screen, touch  **Apps** →  **Settings** → **Applications** → **Development**.
2. Touch **Stay awake** to enable or disable the setting.  
When enabled, a check mark appears in the check box.

## Allow mock locations

This setting is used by developers when developing applications.

1. From the Home screen, touch  **Apps** →  **Settings** → **Applications** → **Development**.
2. Touch **Allow mock locations** to enable or disable the setting. When enabled, a check mark appears in the box.

## Accounts and sync

Manage accounts, including your Google, social networking, and Email accounts.

### General sync settings

#### Background data

When enabled, all accounts can sync, send, and receive data at any time, in the background.

---

**Important!:** Disabling background data can extend battery life and lower data use. Some applications may still use the background data connection, even if this setting is disabled.

---

1. From the Home screen, touch  **Apps** →  **Settings** → **Accounts and sync**.
2. Touch **Background data** to enable or disable the setting. When enabled, a check mark appears in the check box.

## Auto-sync

When enabled, all accounts sync data at any time, automatically.

1. From the Home screen, touch  **Apps** →  **Settings** → **Accounts and sync**.
2. Touch **Auto-sync** to enable or disable the setting. When enabled, a check mark appears in the check box.

## Manage accounts

Use Manage accounts to set up and configure your accounts.

---

**Note:** Available settings depend on the type of account. Not all settings are available for all accounts.

---

1. From the Home screen, touch  **Apps** →  **Settings** → **Accounts and sync**.
2. Under **Manage accounts**, touch an account to modify its settings.

## Removing an account

---

**Important!:** Removing an account also deletes all of its messages, contacts and other data from the device.

---

1. From the Home screen, touch  **Apps** →  **Settings** → **Accounts and sync**.
2. Touch an account to display its settings.
3. Touch **Remove account**, then follow the prompts to remove the account and delete all its messages, contacts and other data.

## Motion

When Motion settings are enabled, your device responds to motions you make with the device, such as tilting or panning.

1. From the Home screen, touch  **Apps** →  **Settings** → **Motion**.
2. Touch **Motion activation** to enable or disable motion.
3. Touch **Tilt to zoom** to configure tilt options for zooming:
  - **Tilt:** Enable or disable the tilt motion.
  - **Sensitivity:** Set the amount of tilt motion needed to zoom.

---

**Tip:** Under **Learn about tilt**, view a tutorial about using the tilt motion to zoom on the screen.

---

4. Touch **Pan to edit** to configure panning options for moving icons on the screen:
  - **Pan:** Enable or disable use of a panning motion to move icons.
  - **Sensitivity:** Set the amount of panning motion needed to move icons on the screen.

---

**Tip:** Under **Learn about pan**, view a tutorial about using the panning motion to move icons on the screen.

---

## Privacy

Use Privacy settings to manage use of personal information by your device.

### Backup and restore

#### Back up my data

Enable or disable backup of your current settings and application data to the Google server for the Backup account.

1. From the Home screen, touch  **Apps** →  **Settings** → **Privacy**.
2. Touch **Back up my data** to enable or disable backup of data to the Google server.

#### Backup account

This is the Google account where your settings and other data are backed up. You would sign in to this account with a new device, to restore the settings from the account to the device.

1. From the Home screen, touch  **Apps** →  **Settings** → **Privacy**.
2. Touch **Backup account** to view the account.

## Automatic restore

When enabled, Automatic restore will restore backed-up settings when you reinstall an application.

1. From the Home screen, touch  **Apps** →  **Settings** → **Privacy**.
2. Touch **Automatic restore** to enable or disable automatic restoration of settings from the Google server.

## Personal Data

### Factory data reset

Use Factory data reset to return your device to its factory defaults. This setting erases all data from your device, including your Google or other email account settings, system and application data and settings, and downloaded applications. After a reset, you'll be prompted to set up your device the next time you turn it on.

1. From the Home screen, touch  **Apps** →  **Settings** → **Privacy**.
2. Touch **Factory data reset**, then follow the prompts to perform the reset.

## Storage

Monitor usage for your device's internal memory, and for installed memory cards.

### Device memory

1. From the Home screen, touch  **Apps** →  **Settings** → **Storage**.
2. Under Device memory, view Total space and Available memory usage, and view space used by Applications and Miscellaneous files.

---

**Tip:** Touch Applications to launch Applications settings, for more information about applications installed on your device.

---

### SD card

1. From the Home screen, touch  **Apps** →  **Settings** → **Storage**.
2. Under SD card, view Total space and Available space memory usage on an installed memory card.
3. Touch **Unmount SD card** to prepare the memory card for safe removal or formatting.
4. Touch **Format SD card** to erase the memory card and prepare it for use with your device.

## Language and input

Select a language for your device's screens, and configure other input options.

### Language settings

#### Select language

Set the language used by your device's screens.

1. From the Home screen, touch  **Apps** →  **Settings** → **Language and input** → **Select language**.
2. Touch a language from the list.

### Voice input

Configure options for entering text by speaking.

#### Voice recognition settings

Configure voice input.

1. From the Home screen, touch  **Apps** →  **Settings** → **Language and input**.
2. Touch **Voice recognition settings** for these options:
  - **Language**: Choose the default language for voice input.
  - **SafeSearch**: Set the sensitivity for filtering of explicit images from the results of your Google voice searches.

- **Block offensive words**: Enable to hide words many people find offensive in results of Google voice searches. Offensive words are replaced in search results with a placeholder (#####).
- **Personalized recognition**: Enable to allow Google to store and use recordings of your voice inputs when using Voice Search and entering text by speaking, to improve voice recognition for your voice. Touch More information for additional details.
- **Google Account dashboard**: Open your Google Account dashboard in Browser, to view and manage information associated with your Google Account that is stored on Google servers.

## Voice output

Configure options for reading out text via your device's speech synthesizer.

### Text-to-speech settings

Configure voice output.

1. From the Home screen, touch  **Apps** →  **Settings** → **Language and input** → **Text-to-speech settings**.
2. Configure these options:
  - **Listen to example:** If you have enabled a speech synthesizer, play a brief sample of voice output.
  - **Always use my settings:** When enabled, settings you make override an application's default settings.
  - **Default Engine:** Choose a default speech synthesizer engine.
  - **Install voice data:** Download and install voice data from Android Market (free).
  - **Speech rate:** Choose the speed at which text is spoken.
  - **Language:** Choose a voice for spoken text.
  - **Samsung TTS:** Configure the Samsung text-to-speech engine.
  - **Pico TTS:** Configure the Pico text-to-speech engine.

## Keyboard settings

Configure the keyboard to your preferences.

### Current input method

Choose the default method for entering text.

1. From the Home screen, touch  **Apps** →  **Settings** → **Language and input** → **Current input method**.
2. Touch a default text entry mode.

### Input method selector

Choose whether the selector for input methods displays in the System bar when the cursor is in a text field.

1. From the Home screen, touch  **Apps** →  **Settings** → **Language and input** → **Input method selector**.
2. Touch an option.

## Configure input methods

Choose settings for input methods you have installed, including voice input and keyboard(s).

1. From the Home screen, touch  **Apps** →



**Settings** → **Language and input** → **Configure input methods**.

2. For **Swype**, touch **Settings** to configure options:
  - **Select Input Method**: Touch to set the default input method.
  - **How to Swype**: Learn about Swype.
  - **Personal dictionary**: Manage your personal dictionary of words, used by Swype for word suggestions and correction.
  - **Preferences**: View and modify Swype options.
    - **Audio Feedback**: When enabled, plays sounds as you enter text.
    - **Vibrate on keypress**: When enabled, the phone vibrates on text entry.
    - **Show tips**: When enabled, helpful tips appear on screen as you enter text.
    - **Auto-spacing**: When enabled, inserts spaces automatically when you pause while entering text.

- **Auto-capitalization**: When enabled, automatically capitalizes the first letter of the first word in a sentence.
- **Show complete trace**: Enable or disable display of the Swype path as you draw it.
- **Word suggestion**: When enabled, predicts matching words as you enter text.
- **Speed vs. accuracy**: Configure how quickly Swype responds to your input.
- **Reset Swype's dictionary**: Delete all the words you've added to your personal Swype dictionary.
- **About**: View the version of Swype software.

- **Language options**: Activate languages for use with Swype, and select the default language.

3. For **Android keyboard**, configure options:

- **Active input methods**: Choose **Use system language** to use the language you selected at device set-up, or select languages to be available for typing and speaking when using the Android keyboard and voice input.
- **Settings**:

- **Auto-capitalization:** Enable to have the on-screen keyboard automatically capitalize the first letter of the first word after a period, the first word in a text field, and each word in name fields.

    - **Recapture:** When enabled, XT9 re-displays matching words when you make corrections to a word inserted automatically.
    - **XT9 my words:** Add words to your XT9 predictive text dictionary.
    - **XT9 auto-substitution:** Manage the list of words XT9 uses for auto-substitution.
  - **Period (.) shortcut:** Enable for automatic insertion of a period and space, to end a sentence, when you tap the space bar twice.

- **Auto-capitalization:** Enable to have XT9 automatically capitalize words in your text based on common usage, such as at the beginning of sentences.
- **Voice input:** Enable to allow text entry by speaking the words, using Google's networked speech recognition feature.
- **Handwriting settings:** Set options for handwriting recognition.
  - **Recognition time:** Choose the length of time between stopping handwriting and Samsung keypad's attempt to recognize your input.
  - **Pen thickness:** Select the size of the line used when handwriting on- screen.
  - **Pen color:** Choose the color of the handwriting trace line.
  - **Recognition type:** Choose how Samsung keypad attempts to interpret your input.
  - **About:** View information about Samsung keypad handwriting recognition.
- **Tutorial:** View an interactive tutorial about using Samsung keypad and XT9 predictive text.

## Accessibility

Accessibility refers to special features that make using the device easier for those with certain physical disabilities.

1. From the Home screen, touch  **Apps** →  **Settings** → **Accessibility**.
2. Touch **Accessibility** to enable or disable accessibility features. When activated, a check appears in the box.

## Accessibility applications

Enable or disable accessibility services. Some accessibility services may be installed by default, or you may install additional applications and enable them here.

---

**Note:** You must enable **Accessibility services** before enabling services.

---

1. From the Home screen, touch  **Apps** →  **Settings** → **Accessibility**.
2. Touch **TalkBack** to enable or disable the service. When enabled, a check mark appears in the check box. **TalkBack** recites menu options, application titles, contacts, and other items when scrolling and making selections.

## Accessibility scripts

When enabled, applications can download accessibility scripts from Google. Accessibility scripts can make content more accessible.

---

**Note:** You must enable **Accessibility services** before enabling scripts.

---

1. From the Home screen, touch  **Apps** →  **Settings** → **Accessibility**.
2. Touch **Download accessibility scripts**, then follow the prompts.

## Touch screen controls

Set the length of time to wait before the device interprets a tap as a tap and hold gesture.

1. From the Home screen, touch  **Apps** →  **Settings** → **Accessibility**.
2. Touch **Tap and hold delay** and then select a delay period.

## Vision

Use the Flashlight option to turn on the camera's flash as a flashlight.

1. From the Home screen, touch  **Apps** →  **Settings** → **Accessibility**.
2. Touch **Flashlight** to turn the light on or off.

## Audio

Use the Mono audio option to play all sounds together, to facilitate listening with only one earphone.

1. From the Home screen, touch  **Apps** →  **Settings** → **Accessibility**.
2. Touch **Mono audio** to turn the option on or off.

## Easy access

Use the Accessibility shortcut to make accessibility options easily available when you press and hold the **Power/Lock Key**. When the option is turned on, Accessibility appears in the Device options when you press and hold the **Power/Lock Key**, to provide easy access to these Accessibility options.

1. From the Home screen, touch  **Apps** →  **Settings** → **Accessibility**.
2. Touch **Accessibility shortcut** to turn the option on or off.

## Date & time

By default, your device receives date and time information from the wireless network. When you are outside network coverage, you may want to set date and time information manually using Date & time settings.

1. From the Home screen, touch  **Apps** →  **Settings** → **Date and time**.
2. Touch a setting to configure:
  - **Automatic date and time:** Touch to enable or disable automatic date and time updates from the wireless network. When enabled, a check appears in the check box.
  - **Set date:** Enter the current date (only available when the Automatic date & time setting is disabled).
  - **Set time:** Enter the current time (only available when the Automatic setting is disabled).
  - **Select time zone:** Choose your local time zone (only available when the Automatic date & time setting is disabled).
  - **Use 24-hour format:** Set the format for time displays.
  - **Select date format:** Set the format for date displays.

## About device

View information about your device, including status, legal information, hardware and software versions, and a tutorial.

1. From the Home screen, touch  **Apps** →  **Settings** → **About device**.
2. Touch items to view details:
  - **System updates:** Check availability and install updates.
  - **Status:** View Battery status, Battery level, MDN, PRL version, ERI version, SIM ID, Network, Signal strength, EVDO/4G LTE Signal strength, Mobile network type, Service state, Roaming, Mobile network state, IMEI, Wi-Fi MAC address, Bluetooth address, and Up time.
  - **Battery use:** Display the processes and applications that are currently running. Touch an item to view details.
  - **Legal information:** Display open source licenses, configure license settings (including the DivX<sup>®</sup> VOD registration process), and view Google legal info.
  - **Hardware version:** Display the hardware version of your device.
  - **Model number:** Display your device's model number.
  - **Android version:** Display the firmware version of your device.

- **Baseband version:** Display the baseband version of your device.
- **Kernel version:** Display the kernel version of your device.
- **Build number:** Display your device's build number.

## Section 11: Health and Safety Information

---

This section outlines the safety precautions associated with using your Galaxy Tab. The terms “GALAXY” or “mobile device” are used in this section to refer to your Galaxy Tab.

**Read this information before using your mobile device.**

### Exposure to Radio Frequency (RF) Signals

Although GALAXY is not a cell phone, it can operate on the same network as cell phones and can use the same Radio Frequency (RF) signals to communicate with the network as a cell phone. Therefore, although the following information refers specifically to RF exposure from wireless phones, it may apply similarly to GALAXY when it is being used on a cell phone network.

The U.S. Food and Drug Administration (FDA) has published information for consumers relating to Radio Frequency (RF) exposure from wireless phones. The FDA publication includes the following information:

#### *Do cell phones pose a health hazard?*

Many people are concerned that cell phone radiation will cause cancer or other serious health hazards. The weight of scientific evidence has not linked cell phones with any health problems.

Cell phones emit low levels of Radio Frequency (RF) energy. Over the past 15 years, scientists have conducted hundreds of studies looking at the biological effects of the radio frequency energy emitted by cell phones. While some researchers have reported biological changes associated with RF energy, these studies have failed to be replicated. The majority of studies published have failed to show an association between exposure to radio frequency from a cell phone and health problems.

The low levels of RF cell phones emit while in use are in the microwave frequency range. They also emit RF at substantially reduced time intervals when in the stand-by mode. Whereas high levels of RF can produce health effects (by heating tissue), exposure to low level RF that does not produce heating effects causes no known adverse health effects.

The biological effects of radio frequency energy should not be confused with the effects from other types of electromagnetic energy.

Very high levels of electromagnetic energy, such as is found in X-rays and gamma rays, can ionize biological tissues. Ionization is a process where electrons are stripped away from their normal locations in atoms and molecules. It can permanently damage biological tissues including DNA, the genetic material.

The energy levels associated with radio frequency energy, including both radio waves and microwaves, are not great enough to cause ionization of atoms and molecules. Therefore, RF energy is a type of non-ionizing radiation. Other types of non-ionizing radiation include visible light, infrared radiation (heat), and other forms of electromagnetic radiation with relatively low frequencies.

While RF energy does not ionize particles, large amounts can increase body temperatures and cause tissue damage. Two areas of the body, the eyes and the testes, are particularly vulnerable to RF heating because there is relatively little blood flow in them to carry away excess heat.

## **Research Results to Date: Is there a connection between RF and certain health problems?**

The results of most studies conducted to date say no. In addition, attempts to replicate and confirm the few studies that have shown a connection have failed.

The scientific community at large therefore believes that the weight of scientific evidence does not show an association between exposure to Radio Frequency (RF) from cell phones and adverse health outcomes. Still the scientific community has supported additional research to address gaps in knowledge. Some of these studies are described below.

### **Interphone Study**

Interphone is a large international study designed to determine whether cell phones increase the risk of head and neck cancer. A report published in the International Journal of Epidemiology (June, 2010) compared cell phone usage for more than 5,000 people with brain tumors (glioma and meningioma) and a similar number of healthy controls.

Results of this study did NOT show that cell phones caused brain cancer. In this study, most people had no increased risk of brain cancer from using cell phones. For people with the heaviest use of cell phones (an average of more than ½ hour

per day, every day, for over 10 years) the study suggested a slight increase in brain cancer. However, the authors determined that biases and errors prevented any conclusions being drawn from this data. Additional information about Interphone can be found at

Interphone is the largest cell phone study to date, but it did not answer all questions about cell phone safety. Additional research is being conducted around the world, and the FDA continues to monitor developments in this field.

### **International Cohort Study on Mobile Phone Users (COSMOS)**

The COSMOS study aims to conduct long-term health monitoring of a large group of people to determine if there are any health issues linked to long-term exposure to radio frequency energy from cell phone use. The COSMOS study will follow approximately 300,000 adult cell phone users in Europe for 20 to 30 years. Additional information about the COSMOS study can be found at

### **Risk of Brain Cancer from Exposure to Radio Frequency Fields in Childhood and Adolescence (MOBI-KIDS)**

MOBI-KIDS is an international study investigating the relationship between exposure to radio frequency energy from communication technologies including cell phones and brain cancer in young people. ### **Surveillance, Epidemiology, and End Results (SEER) Program of the National Cancer Institute**

The National Cancer Institute (NCI) actively follows cancer statistics in the United States to detect any change in rates of new cases for brain cancer. If cell phones play a role in risk for brain cancer, rates should go up, because heavy cell phone use has been common for quite some time in the U.S. Between 1987 and 2005, the overall age-adjusted incidence of brain cancer did not increase. ## Cell Phone Industry Actions

Although the existing scientific data do not justify FDA regulatory actions, the FDA has urged the cell phone industry to take a number of steps, including the following:

- Support-needed research on possible biological effects of RF for the type of signal emitted by cell phones;
- Design cell phones in a way that minimizes any RF exposure to the user; and
- Cooperate in providing users of cell phones with the current information on cell phone use and human health concerns.

The FDA also is working with voluntary standard-setting bodies such as the Institute of Electrical and Electronics Engineers (IEEE), the International Commission on Non-ionizing Radiation Protection (ICNIRP), and others to assure that safety standards continue to adequately protect the public.

## ***Reducing Exposure: Hands-Free Kits and Other Accessories***

### **Steps to Reduce Exposure to Radio Frequency Energy**

If there is a risk from being exposed to radio frequency energy (RF) from cell phones - and at this point we do not know that there is - it is probably very small. But, if you are

concerned about avoiding even potential risks, you can take a few simple steps to minimize your RF exposure.

- Reduce the amount of time spent using your cell phone;
- Use speaker mode or a headset to place more distance between your head and the cell phone.

### **Hands-Free Kits**

Hands-free kits may include audio or Bluetooth® headsets and various types of body-worn accessories such as belt-clips and holsters. Combinations of these can be used to reduce RF energy absorption from cell phones.

Headsets can substantially reduce exposure because the phone is held away from the head in the user's hand or in approved body-worn accessories. Cell phones marketed in the U.S. are required to meet RF exposure compliance requirements when used against the head and against the body.

Because there are no known risks from exposure to RF emissions from cell phones, there is no reason to believe that hands-free kits reduce risks. Hands-free kits can be used for convenience and comfort. They are also required by law in many states if you want to use your phone while driving.

## Cell Phone Accessories that Claim to Shield the Head from RF Radiation

Because there are no known risks from exposure to RF emissions from cell phones, there is no reason to believe that accessories which claim to shield the head from those emissions reduce risks. Some products that claim to shield the user from RF absorption use special phone cases, while others involve nothing more than a metallic accessory attached to the phone. Studies have shown that these products generally do not work as advertised. Unlike “hands-free” kits, these so-called “shields” may interfere with proper operation of the phone. The phone may be forced to boost its power to compensate, leading to an increase in RF absorption.

## Children and Cell Phones

The scientific evidence does not show a danger to any users of cell phones from RF exposure, including children and teenagers. The steps adults can take to reduce RF exposure apply to children and teenagers as well.

- Reduce the amount of time spent on the cell phone;
- Use speaker mode or a headset to place more distance between the head and the cell phone.

Some groups sponsored by other national governments have advised that children be discouraged from using cell phones at all. For example, The Stewart Report from the United Kingdom made such a recommendation in December 2000. In this report, a group of independent experts noted that no evidence exists that using a cell phone causes brain tumors or other ill effects. Their recommendation to limit cell phone use by children was strictly precautionary; it was not based on scientific evidence that any health hazard exists.

## **Specific Absorption Rate (SAR) Certification Information**

Your wireless mobile device is a radio transmitter and receiver. It is designed and manufactured not to exceed the exposure limits for Radio Frequency (RF) energy set by the Federal Communications Commission (FCC) of the U.S. Government.

These FCC RF exposure limits are derived from the recommendations of two expert organizations: the National Council on Radiation Protection and Measurement (NCRP) and the Institute of Electrical and Electronics Engineers

(IEEE). In both cases, the recommendations were developed by scientific and engineering experts drawn from industry, government, and academia after extensive reviews of the scientific literature related to the biological effects of RF energy.

The RF exposure limit set by the FCC for wireless mobile devices employs a unit of measurement known as the Specific Absorption Rate (SAR). The SAR is a measure of the rate of absorption of RF energy by the human body expressed in units of watts per kilogram (W/kg). The FCC requires wireless devices to comply with a safety limit of 1.6 watts per kilogram (1.6 W/kg).

The FCC SAR limit incorporates a substantial margin of safety to give additional protection to the public and to account for any variations in measurements.

SAR tests are conducted using standard operating positions accepted by the FCC with the mobile device transmitting at its highest certified power level in all tested frequency bands. Although the SAR is determined at the highest certified power level, the actual SAR level of the mobile device while operating can be well below the maximum reported value. This is because the mobile device is designed to operate at multiple power levels so as to use only the power required to

reach the network. In general, the closer you are to a wireless base station antenna, the lower the power output of the mobile device.

Before a new model mobile device is available for sale to the public, it must be tested and certified to the FCC that it does not exceed the SAR limit established by the FCC. Tests for each model mobile device are performed in positions and locations (e.g. near the body) as required by the FCC.

For typical operations, this mobile device has been tested and meets FCC SAR guidelines.

Use of other accessories may not ensure compliance with FCC RF exposure guidelines. The FCC has granted an Equipment Authorization for this mobile device with all reported SAR levels evaluated as in compliance with the FCC RF exposure guidelines. The maximum SAR value for this model device as reported in the FCC equipment authorization grant is:

- Body-worn: 1.09 W/kg.

Damage to hearing occurs when a person is exposed to loud sounds over time. The risk of hearing loss increases as sound is played louder and for longer durations.

Prolonged exposure to loud sounds (including music) is the most common cause of preventable hearing loss. Some scientific research suggests that using portable audio devices, such as portable music players and cell phones, at high volume settings for long durations may lead to permanent noise-induced hearing loss. This includes the use of headphones (including headsets, earbuds, and Bluetooth® or other wireless devices).

Exposure to very loud sound has also been associated in some studies with tinnitus (a ringing in the ear), hypersensitivity to sound, and distorted hearing. Individual susceptibility to noise-induced hearing loss and potential hearing problem varies. Additionally, the amount of sound produced by a portable audio device varies depending on the nature of the sound, the device settings, and the headphones that are used. As a result, there is no single volume setting that is appropriate for everyone or for every combination of sound, settings, and equipment.

You should follow some common sense recommendations when using any portable audio device:

- Always turn the volume down before plugging the earphones into an audio source.
- Set the volume in a quiet environment and select the lowest volume at which you can hear adequately.
- Be aware that you can adapt to higher volume settings over time, not realizing that the higher volume may be harmful to your hearing.
- When using headphones, turn the volume down if you cannot hear the people speaking near you or if the person sitting next to you can hear what you are listening to.
- Do not turn the volume up to block out noisy surroundings. If you choose to listen to your portable device in a noisy environment, use noise-cancelling headphones to block out background environmental noise. By blocking background environment noise, noise cancelling headphones should allow you to hear the music at lower volumes than when using earbuds.
- Limit the amount of time you listen. As the volume increases, less time is required before your hearing could be affected.

- Avoid using headphones after exposure to extremely loud noises, such as rock concerts, that might cause temporary hearing loss. Temporary hearing loss might cause unsafe volumes to sound normal.
- Do not listen at any volume that causes you discomfort. If you experience ringing in your ears, hear muffled speech, or experience any temporary hearing difficulty after listening to your portable audio device, discontinue use and consult your doctor.

## Operating Environment

Remember to follow any special regulations in force in any area, and always switch your mobile device off whenever it is forbidden to use it, or when it may cause interference or danger. When connecting the mobile device or any accessory to another device, read its user's guide for detailed safety instructions. Do not connect incompatible products.

## Using Your Mobile Device Near Other Electronic Devices

Most modern electronic equipment is shielded from Radio Frequency (RF) signals. However, certain electronic equipment may not be shielded against the RF signals from your wireless mobile device. Consult the manufacturer to discuss alternatives.

## Implantable Medical Devices

A minimum separation of six (6) inches should be maintained between a handheld wireless mobile device and an implantable medical device, such as a pacemaker or implantable cardioverter defibrillator, to avoid potential interference with the device.

Persons who have such devices:

- Should ALWAYS keep the mobile device more than six (6) inches from their implantable medical device when the mobile device is turned ON;
- Should not carry the mobile device in a breast pocket;
- Should use the ear opposite the implantable medical device to minimize the potential for interference;
- Should turn the mobile device OFF immediately if there is any reason to suspect that interference is taking place;
- Should read and follow the directions from the manufacturer of your implantable medical device. If you have any questions about using your wireless mobile device with an implantable medical device, consult your health care provider.

## **Other Medical Devices**

If you use any other personal medical devices, consult the manufacturer of your device to determine if it is adequately shielded from external RF energy. Your physician may be able to assist you in obtaining this information. Switch your mobile device off in health care facilities when any regulations posted in these areas instruct you to do so. Hospitals or health care facilities may be using equipment that could be sensitive to external RF energy.

## **Vehicles**

RF signals may affect improperly installed or inadequately shielded electronic systems in motor vehicles. Check with the manufacturer or its representative regarding your vehicle before using your mobile device in a motor vehicle. You should also consult the manufacturer of any equipment that has been added to your vehicle.

## **Posted Facilities**

Switch your mobile device off in any facility where posted notices require you to do so.

## **Potentially Explosive Environments**

Switch your mobile device off when in any area with a potentially explosive atmosphere and obey all signs and instructions. Sparks in such areas could cause an explosion or fire resulting in bodily injury or even death. Users are advised to switch the mobile device off while at a refueling point (service station).

Users are reminded of the need to observe restrictions on the use of radio equipment in fuel depots (fuel storage and distribution areas), chemical plants, or where blasting operations are in progress. Areas with a potentially explosive atmosphere are often, but not always, clearly marked. They include below deck on boats, chemical transfer or storage facilities, vehicles using liquefied petroleum gas (such as propane or butane), areas where the air contains chemicals or particles, such as grain, dust, or metal powders, and any other area where you would normally be advised to turn off your vehicle engine.

## **When your Device is Wet**
